		Seeking CV of key personnel is specific for a team of consultants who suppose to engage to render any specific job ie Preparation of Master Plans/DPR/Advisory Services, Feasibility Studies etc. Where Highly Skilled personnel required and their qualification/experience and specialisation on subject is vital. But for regular posts like Driver/Data Entry Operators etc such parameter is seems inappropriate	Only required for IT Assistant and Assistant Account Officer.
