General Terms & Conditions

1. The items should be as per **MoRTH** specifications.
2. Dealers/Firms/ Contractors/ Suppliers must be empaneled/ registered in any Central Govt/ State Govt., PSU's, MES, CPWD, Railways, BRPNNL for the works.
3. Quotationers/Their Authorized representatives may present themselves at the time of opening of the quotations.
4. The rate should be quoted per unit inclusive all taxes, carriage and installation.
5. Warranty/Guarantee should be as per **MoRTH**.
6. Over head expenses (like quality control, site office, godown, electricity, water, monitoring, inspection vehicle, VAT, etc.) will be beared by bidder.
7. Payment will be made after supply and successful installation and subject to availability of fund.
8. The bidder shall submit following documents:
 - (a) PAN Card.
 - (b) The constitution of the company of bidder shall be enclosed.
 - (c) Power of Attorney. (If any)
 - (d) Proof of executing orders received from Govt./Govt. undertaking PSU.
 - (e) An affidavit by the bidder in proof of not being blacklisted / debar by any Govt. or semi Govt organization. Affidavit must be between opening date and bid submission date of the quotation.
9. Prequalification conditions/ requirements :

Agency must fulfill following criteria and upload relevant documents :

- i) Experience Strip Seal/slab type expansion joints in last three years (minimum 120mtr).
 - ii) Experience of replacement of POT bearings in last five years (minimum 5 spans) on a single high level Major Bridge over a River.
 - iii) Ownership of minimum 2 Nos. specialized gantries/suspended platforms
 - iv) One Nos. Graduate Civil Engineers having minimum 5 years of similar work experience.
10. Work of repairs to the Vikramshila Bridge including Jacking up of superstructure, replacement of POT Bearing and Expansion Joints etc. is already under progress by another agency. The execution of items covered by this enquiry will have to be synchronized/ co- ordinate with that agency as per their planning. No additional payment for idling of manpower and machinery shall be paid on this account.
 11. Bid security
 - 9.1 The applicant shall furnish as part of its Proposal, a Bid Security of Rs. 200,000.00 (Rupees Two Lakhs only) in the form of a Bank Guarantee/ Demand Draft issued by one of the Nationalized /Scheduled Banks in India in favour of the 'Senior Project Engineer, Special Works Division, Khagaria' payable at Khagaria (the "Bid Security") valid for a minimum period of 150 days (i.e.30 days beyond the validity of the bid) from the last date of submission of proposals. This Bid Security is returnable not later than 30 (thirty) days from the date of Opening of the Financial proposals except in case of the highest ranked Applicant. Bid Security of the Selected Applicant and the Second ranked
 - 9.2 Any Bid not accompanied by the Bid Security of the required value and minimum required validity shall be rejected by the Authority as non-responsive.
 - 9.3 The BRPNNL shall not be liable to pay any interest on the Bid Security and the same shall be interest free.
 - 9.4 The Applicant, by submitting its Application pursuant to this NIT, shall be deemed to have acknowledged that without prejudice to the BRPNNL's any other right or remedy hereunder or in law or otherwise, the Bid Security shall be forfeited and appropriated by the Authority as the mutually agreed pre-estimated compensation and damage payable to the Authority for, inter alia the time, cost and effort of the BRPNNL in regard to NIT including the consideration and evaluation of the Proposal under the following conditions:
 - (a) If an Applicant withdraws its Proposal during the period of its validity as specified in this NIT and as extended by the Applicant from time to time;
 - (b) In the case of the Selected Applicant, if the Applicant fails to reconfirm its commitments during negotiations.
 - (c) In the case of a Selected Applicant, if the Applicant fails to sign the Agreement.
