Parking Rates

1. Scooter/Motorcycle Rs. 5/-for the first three hours or part thereof Rs. 3/- extra will be charged for each subsequent hour or part thereof .
2. LCV/Car/Jeep/ Ambulance & other types four and three wheeled vehicles etc. Rs. 20/- for the first three hours or part thereof and Rs. 10/- extra for each one subsequent hour or part thereof.

Terms and conditions

1. Highest bidder will have to deposit One third (excluding earnest money) of bid amount in the office of undersigned on the same day and remaining amount will be deposited in two equal installments in the 2nd and 3rd month from start of the collection. If he fails to do so, the second highest bidder will be given opportunity to deposit One third (excluding earnest money) of the highest bid amount. The earnest money will be refunded to all bidders other than the awardee
2. Parking site inspection with full details should be done by the bidders before giving the bid. This settlement will be valid for one year. The Bihar Rajya Pul Nirman Nigam Ltd has the right to foreclose without assigning any reason the settlement by giving one prior month notice to the successful tenderer. In such event the calculation of payable amount will be fixed on pro-rata basis.
3. No Shop/Stall /Permanent or temporary structure will be allowed on the parking space. If found, the agreement will be rescinded and earnest money will be forfeited. In addition the agency will be liable to pay an amount equal to 1/12 of the agreement value by way of penalty
4. No advertisement will be allowed on the parking space and bridge pier structure/ shaft. If such advertisement is found, the contract will be rescinded and earnest money will be forfeited. In addition the agency will be liable to pay an amount equal to 1/12 of the agreement value by way of penalty.
5. The parking agency has to maintain sanitation, cleanliness and up keep of the parking area.
6. The parking agency has to provide adequate security of parked vehicles against theft / pilferage .
7. The parking agency has to maintain lighting arrangement in the parking area as well as on the flyover. The agency is responsible to replace and reinstall the bulb(s) and lighting tools in case of damage, theft or malfunctioned / fuse in the entire flyover including parking site as well as upper flyover area.
8. If the Road Construction Department/ Bihar Rajya Pul Nirman Nigam Ltd., desires to undertake any development activity in the parking space during the period of settlement, the allottee will not obstruct the same in any manner overtly or covertly.

9. Parking area may be increase or decrease, accordingly cost will be adjusted on pro-rata basis.
10. Repair and maintenance and upkeep for one year, of electrification and lighting over and under the flyover and in the entire parking area and maintenance of electric poles of Jagdeo Path Four lane flyover, Bailey Road at Patna will be responsibility of the allottee.
11. The initial contract period shall be for one year in the first instance and the same may be extended with the approval of the Government, on payment of further sum calculated on pro-rata basis.
12. The prospective bidders are advised to visit the site before submitting the offer. However, It will be deemed that the offer have been submitted after due inspection and full knowledge of the site conditions.
13. Any other details including norms of IRC/MOST can be had from the office of the Managing Director/Dy. Chief Engineer, Bihar Rajay Pul Nirman Nigam Ltd/ and office of the undersigned.
14. Authority reserves the right to accept or reject any offer without assigning any reason thereof.
15. It will be the responsibility of the Licensee licenses to maintain all the lights on all the electric poles on Jagdeo Path Four lane flyover, Bailey Road at Patna during the entire lease period.
16. That the licensee will meet the cost of all such replacement of electrical fittings, cable and accessories. The Government shall not pay any charge on any such account.
17. That the licensee, in lieu of maintenance of lights on Jagdeo Path Four lane flyover, Bailey Road at Patna may erect double sided display sign boards of size not exceeding 2 x 3 feet each on electrical poles at a minimum height of 2 metres above railing, for which licensee may charge the owner of the advertisement material. He shall not be required to pay any charge to the government on this account.
18. That the licensee shall keep free for the department, every 10th pole to carry signage provided by the department.
19. That the licensee shall fix the display signs on the electrical poles in such a manner they do not obstruct the movement of the traffic in any way.
20. The licensee shall insure that all such advertisement confirm to norms of IRC/MOST.

21. That the licensee shall be solely responsible for structural stability of the sign boards etc.
22. That the licensee shall be liable for any loss or damage to the Government on account of obstruction caused by erection of such sign boards etc.
23. That the licensee, within two months of a notice duly given to them in this behalf by the Senior Project Engineer, Works Division no. 1, Patna, shall, at their own cost, remove the display sign when required to do so by the government. The licensee shall not be entitled to any compensation on account of such removal. Any advertisement perceived as offensive / inappropriate by the department shall have to be removed at immediate notice.
24. That if the licensee fails to execute the any work which they have agreed to execute under this agreement to the entire satisfaction of the Senior Project Engineer, Works Division No. 1, Patna the same shall be executed by the Senior Project Engineer, Work Division No. 1, Patna at the cost of licensee and the amount shall be recoverable from the licensee as the penalty / fine without prejudice to any other remedies which may be open to the government in this regard.
25. That the licensee shall not sell, transfer or otherwise dispose of the board space to another sponsor.
26. That the agreement will remain enforce for a maximum period of ONE YEAR in the first instance.
27. That the permission granted by this licensee shall not be deemed to convey to the licensee any right for or any interest in Government property other than what is herein specifically granted.
28. That during the period of this license, the display sign boards located on electrical poles shall be deemed to have been erected and continued with the consent and permission of the Government. The right of the licensee to the use thereof shall not become obsolete in the duration of the license.
29. Any electrical malfunction including fuse bulb shall be rectified by the licensee within 48 hours of first intimation/ discovery of fault falling which, a penalty of Rs. 2000.00 per day should be charged until the fault is rectified .
30. Licensee has to submit to BRPNN Ltd, a copy of the receipt for paid electricity bill within a week of payment of the same.
