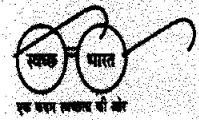



**Project Background and Objectives:** With an aim to make India clean, the Swachh Bharat Mission (Urban) was launched by the Government of India on 2nd October 2014. One of the key goals of the mission is to achieve 100% scientific processing of municipal solid waste (MSW).

As per the goals and objectives of the Swachh Bharat Mission Phase 2.0, Urban Development and Housing Department, Bihar wished to empanelment of agencies for set up the viable technological option for Solid waste, Legacy and Plastic processing/recycling plant in the Various Urban Local bodies in Bihar to reduce the amount of waste reduction going on the landfill site.

Additionally, a variety of innovative initiatives such as Swachh Survekshan, ODF / ODF+ / ODF++ protocols and Star Rating protocols for Garbage Free cities, various ICT interventions etc. have been introduced to accelerate Mission implementation. Hence, it is imperative to continue the Mission for a period of five years, from 2020-21 to 2024-25 with a focus on sustaining the sanitation and SWM outcomes achieved under SBM (U).

As per Solid Waste Management Rules 2016, it is the duty of the local authority to develop and set up infrastructure for Segregation, Collection, Storage, Transportation, Processing and disposal of the Solid and plastic waste either on its own or by engaging agencies or producers;

Urban Development and Housing Department, Bihar intends to empanelment of agencies for set up the Solid waste management facility (collection and treatment of plastic waste) in Urban local Bodies in Bihar, where the agency shall be responsibility for setting up the Solid, plastic and C&D waste collection centers and establish a recycling plant on BOOT (Build, Own, Operate and Transfer) basis for the period of 20 years.

The choice of technology/methodology/ business model/ decision on type of Solid and plastic to be treated is open at this time and will be decided by a technical committee of UD & HD, Bihar on evaluation of responses to this EOI.

**1. Request for Expression of Interest (EOI)**

Urban Development & Housing Department, Govt. Of Bihar invites Expression of Interest for Engagement of agencies for work under waste management (solid waste, plastic waste, construction and demolition waste and legacy waste) in different urban local bodies of state Bihar.

**2. Validity of EOI**

The EOI shall be valid for a period of 120 days. Urban Development & Housing Department reserves the right to reject any EOI which does not meet the requirement.

**3. Eligibility Criteria:**

The agency or its group company should have set up and commissioned at least 02 (Two) Successful model on Solid and plastic waste management facility for government or semi government body.

- i. In case of non-Indian entities, should not have been named in any sanction from any nation, nor should have been held guilty under various anti-corruption/anti-mal practice laws worldwide. An undertaking to the effect must be furnished.
- ii. The agency should submit the following documents

- a. List of similar Waste Management projects (Minimum TWO Successful running) undertaken in the past (including completed and ongoing projects, in India.) with details as per Proforma given in Appendix I.

Further information may be sought by Urban Development & Housing Department if deemed required.

- b. Company Registration certificate and in case of partnership company, partnership deed with power of attorney. In case of non-Indian entity, equivalent documents must be furnished (similarly for items c-f below)
- c. PAN & TAN Card of the firm.
- d. GST registration and clearance
- e. Audited Statement of Accounts for the last three financial years.
- f. List of clients presently being served/served in past for similar work, with Contact name, address and mobile no., accompanied by relevant work orders/ pay orders/ client certificates.

#### 4. Brief description of the Selection Process

This EOI submitted by the agencies will be evaluated by the department. The evaluation processes has basis of total 100 Marks awarded. The marks based on company performance criteria indicated below:

- a. **Company turnover** – 30 Marks
- b. **Company similar experiences** – 20 Marks
- c. **Minimum TWO Successful running, including completed and ongoing projects, in India.**  
- 30 Marks
- d. **Power point presentation** - 20 Marks

On the basis of above evaluation will be done to select the company. The list of Empaneled Company will be published at departmental website. Final RFP will be floated by department to participate on the basis of recommended technology and business model submitted in the EOI for selection of agency to execute the work.

#### 5. Submission of EOIs

The agencies fulfilling the eligibility criteria may submit their application against the EOI as per Performa attached to this document (Appendix I) together with requisite documents up to .....
