Memorandum of Empanelment

Introduction

The owners of taxis / travel agents / taxi fleet owners – Hatchback, Sedan or SUVs are to empanel themselves with Bihar State Tourism Development Corporation Limited (BSTDCL) for providing passenger services at The Airport and other places/offices as and when required.

Eligibility:

1. The taxis should be of the model not later than 2015.
2. The vehicle should be in Good condition mechanically.
3. The Body of the vehicle should be well maintained.
4. The interiors of the taxi should be well kept and clean and well maintained.
5. The Taxi should have commercial license.
6. The driver should have commercial/Professional Driving License.
7. The vehicle should have commercial Insurance covering passengers and third party besides, driver and Vehicle.
8. Empanelment shall be against a security deposit of Rs 5000/- per Vender/Individual Owner of Vehicle.
9. Demand Draft should be in the Name of **BSTDC LTD INCOME A/C TRAVEL & TRADE.**

Conditions of operation:

1. The vehicle shall be operated on commission basis with BSTDCL on the rates charged to the passengers as per its own rates listed and otherwise.
2. The rates shall be decided by BSTDCL.
3. The commission charged by BSTDCL shall be 10 % on the total fare charged to the passenger during the day.
4. During night when the night surcharge is charged to the passengers the commission charged shall be 20%.
5. All Costs including fuel, driver's Salary/expenses, vehicle maintenance, insurance and any other incidental expenses etc. shall be borne by the Taxi owner.
6. All risks and costs shall be borne by the Taxi owner
7. Toll if any shall be borne by the passenger as applicable.
8. Parking required to be made by passenger for his needs shall be borne by passenger as applicable.
9. Parking charges at airport shall be borne by BSTDCL.
10. The taxi shall bear the LOGO and brand of BSTDCL as decided by BSTDCL.

11. The taxi shall be made available to BSTDCL on Regular basis every day.
12. Taxi shall be required to be operated from 7 AM onwards till the last flight at the airport has arrived and passengers have left the airport terminal on every day basis.
In the event of any lapse in providing taxi for 12 hours a penalty of Rs. 1000/- and for a lapse of full day a penalty of Rs. 1500/- shall be imposed. This penalty shall be deducted out of the due amount payable.
MD, BSTDCL shall have the discretion to waive off this penalty amount fully or partially in special circumstances.
13. Necessary arrangement for providing drivers to keep the vehicle to operate regularly and continuously shall be made by the vehicle owner.
The vehicle owner shall ensure continuous operation of the Vehicles without overstraining any individual driver.
14. The Driver shall be well dressed, well-groomed and well behaved.
15. Drivers shall wear the uniform prescribed by the BSTDCL.
16. The driver shall not use any intoxicating substance including gutka, pan, tobacco etc. before or during the duty timings at the taxi.
17. The vehicle owner shall continuously brief the drivers to be well behaved. In case of any adverse feedback received against the driver the vehicle owner shall be required to take appropriate action against the driver.
18. The billing shall be done at the airport by the officials of BSTDCL and the charges shall be collected by BSTDCL.
19. Additional charges if any shall be collected by the Driver and deposited with BSTDCL counter at the airport.

The vehicles shall be empanelled with BSTDCL as per the terms and conditions listed herein for a period of one year initially and can be extended for one year.

Agreement :

I have understood all the terms and conditions of commission, and operations of the taxi with BSTDCL as above and I agree to provide the taxi on regular basis for the full day and every day for one year. In the event of any lapse I shall agree to the penalty imposed by Bihar State Tourism Development Corporation Ltd.
