Selection of Consultancy Firms for the assignment “Preparation of GIS Base Map for 12 Towns of Bihar on 1:1000 Scale”

Scope of Work

- (i) DGPS survey and geo-rectification of satellite data.
- (ii) Auto Level Survey and Contour generation at 0.5 m interval.
- (iii) Features extraction from satellite data and detailed field survey and relevant data collection for the features like Road, Water Network, High Tension Power Network, Cell Phone Towers, Buildings, Land Parcels etc. their database generation and its integration with relevant thematic layers.
- (iv) Spatial database of all the features in GIS format. GIS Base Map generation on different scale like 1:1000, 1:2500 and 1:5000 and 1:750 scale in Hard copy and soft copy.
- (v) Establishment of PBM at every 1 SQ. KM/1 Km.
- (vi) Integration of other available data in GIS.

Eligibility Criteria for participating Consultancy Firm:

- (i) The applicant should be a firm or legal entity registered under Companies Act, Societies or any other law and should have been in operations in India for at least 3 years with the proof of incorporation/ commencement of business (*please attach the registration certificate*).
- (ii) The Firm should have been working in the field of GIS Base Map Preparation or GIS related activities for more than 3 years ending on 31st March 2016 (*please attach copy of work orders and completion certificates received during last 3 years*).
- (iii) Average annual turnover of the Consultancy Firm for the last three financial years ending on March 31st 2016 should be equal to or greater than Rs. 2.5 Crore (*please attach balance sheets and P&L accounts of last 3 years 2013-14, 2014-15 & 2015 - 16*).
- (iv) The Consultancy Firm should have successfully prepared at least GIS Base Map of 2 ULBs/Towns (i.e. GIS Base Map preparation of at least 2 ULBs/Towns using high resolution satellite data for a municipality/ULB in the last three years
- (v) The consultant should also have successfully generated contour for at least 2 ULBs or Towns for GIS base Map/any type of Urban Infra Project through Auto Level/Total Station Survey) in the last three years
- (vi) Bidder should submit details of the project and completion certificate/ work order/

contract agreement or any other related document issued by client and Professional Competence and expertise of the key personnel (both technical and domain experts) to be associated with this project.

- (vii) The Bidder should not be under a declaration of ineligibility for corrupt and fraudulent practices or any other reason, whatsoever, or have not been blacklisted by the Government of India or any of its agencies, including public enterprises and/or by any State Government or any of its agencies. Please submit declaration on bidder's company letter head.
