- 2.1.1** The Bihar State Road Corporation (BSRTC) (the “**Authority**”) has the function to provide Bus Service within the area under its jurisdiction in the entire State of Bihar and as a part of this endeavour, the Authority intends to provide City Bus Service in the identified routes of Bus Service Area in Patna agglomeration area through private sector participation on Public-Private Partnership (the “**PPP**”) basis. It has accordingly decided to carry out the bidding process for selection of an entity/bidder as the operator to whom the Project may be awarded. The operator shall be responsible for Procurement of Buses, Operation and Maintenance of Buses, development of Bus Depot and/or Parking Space (if any) and providing efficient Bus Service in the areas/ routes within the Bus Service Area (routes) (the “**Project**”). The fare-box revenue collection shall also be done by the operator. The selected bidder shall be granted by BSRTC / GoB the exclusive license rights with respect to the following Bus Service Area (routes) on as-is basis. in terms of the concession agreement. The Bus Operator will operate the buses on the following specified routes, maintain the buses and collect the fare and pay the System Management Fee (Licence Fee) to BSRTC:

Regulation and Control Mechanism

The BSRTC shall monitor and control the operation, maintenance and other allied activities towards efficient and quality City Bus Service through Central Control and Command Centre and/or other means/modes as deemed fit by the BSRTC.

The Authority intends to select the suitable Bidder (the “**Bidder**”) who will be eligible to undertake the project in accordance with the procedure set out herein.

2.1.2 The Selected Bidder, a company registered under Companies Act, 1956/2013, shall promote and incorporate a Special Purpose Vehicle (SPV) under the Companies Act, 2013 prior to execution of the Contract (the “**Operator**”) who shall be responsible for undertaking the Project under and in accordance with the provisions of a contract (the “**Contract**”) to be entered into between the Operator and the Authority in the form provided by the Authority as part of the Bidding Documents pursuant hereto.

2.1.3 The detailed scope of work will broadly include to :

- (a) Provide City Bus Service within the Bus Service Area (i.e. in the areas and/ or routes in the city), as specified in the Contract;
- (b) Operate the Buses in compliance with the frequency schedule specified by the Authority from time to time and as specified in the Fleet Deployment Plan (Refer to Schedule IX of Draft Contract);
- (c) Procure Buses as per the Fleet Procurement Schedule. The Operator shall install ITS on Buses as per Bus Specifications (Refer Schedule VII of Draft Contract);
- (d) Provide Driver and Conductor for each Bus, as per the Fleet Procurement Schedule;
- (e) Collect passenger fare from passengers ferried;
- (f) Operate and maintain Buses according to the Operation and Maintenance Standards (Refer Schedule XIV of Draft Contract);
- (g) Maintain Bus Depot and Parking Space (as available with BSRTC) if handed over for the purposes of rendering City Bus Services in the Bus Service Area (route);
- (h) Supply and maintain adequate consumables as required for regular upkeep of Buses;
- (i) Provide appropriate space on the outside and inside of the Buses for the display of non – motion advertisements meeting the requirements of road safety, and collect and appropriate revenue for the same;
- (j) Observe highest standards of safety for the Buses and the passengers during the Operation Period including in respect of Operator’s own staff and personnel;
- (k) Maintain a detailed daily log of performance of each Bus;
- (l) Setup complaint redressal system to redress passenger complaints and issues online and offline;
- (m) Maintain LED display system on Buses, if any;
- (n) Procure all Applicable Permits, as required in conformity with Schedule III of the Draft Contract;
- (o) Ensure Assured Fleet Availability as per the Draft Contract;
- (p) Submit to Authority, monthly reports in formats as required by the Authority.

2.1.4 The tentative estimated cost of the Project (the “**Estimated Project Cost**”) has been specified in the clause 2.1.1 above. The assessment of actual costs, however, will have to be made by the Bidders.

- 2.1.5** The statements and explanations contained in this RFP are intended to provide a better understanding to the Bidders about the subject matter of this RFP and should not be construed or interpreted as limiting in any way or manner the scope of services and obligations of the Operator set forth in the Contract or the Authority's rights to amend, alter, change, supplement or clarify the scope of work, the rights to be awarded pursuant to this RFP or the terms thereof or herein contained. Consequently, any omissions, conflicts or contradictions in the Bidding Documents including this RFP are to be noted, interpreted and applied appropriately to give effect to this intent, and no claims on that account shall be entertained by the Authority.
- 2.1.6** The Authority shall receive Bids pursuant to this RFP in accordance with the terms set forth in this RFP and other documents to be provided by the Authority pursuant to this RFP, as modified, altered, amended and clarified from time to time by the Authority (collectively the "**Bidding Documents**"), and all Bids shall be prepared and submitted in accordance with such terms on or before the date specified in Clause 2.3 for submission of Bids (the "**Bid Due Date**").

2.2 Brief description of Bidding Process

- 2.2.1.** The Authority has adopted a single-stage three envelopes process (referred to as the "**Bidding Process**") for selection of the bidder for award of the Project. The Bidder shall pay to the Authority a sum of INR 5,000/- (Indian Rupees Five Thousand Only) as the cost of the RFP by way of Demand Draft (the "**Demand Draft**") in favour of the Authority along with the Bid.

Government of India has issued guidelines (see **Appendix X**) for qualification of bidders seeking to acquire stakes in any public sector enterprise through the process of disinvestment. These guidelines shall apply mutatis mutandis to this Bidding Process. The Authority shall be entitled to disqualify a Bidder in accordance with the aforesaid guidelines at any stage of the Bidding Process. Bidders must satisfy themselves that they are qualified to bid, and should give an undertaking to this effect in the form at **Appendix I**.

- 2.2.2.** In this process, there will not be a separate pre-qualification phase and the interested parties are required to submit only one Bid. The Bid is to be submitted in three parts, viz.:

Part 1: Test for Responsiveness

Part 2: Technical Bid

Part 3: Financial Bid

The evaluation of the Bids shall be carried out in three stages. The first stage would involve a test for responsiveness (Part 1). Those bids found to be responsive would be evaluated for the next stage: Qualification Stage. In the Qualification Stage, the Technical Bid (Part 2) comprising information of the parties on their technical and financial capability for undertaking the Project would be evaluated. Based on this stage, only those Bids that meet the minimum threshold technical and financial capabilities as set out in the RFP for the Project would be shortlisted/ qualified and their Financial Bid (Part 3) would be opened for selecting the successful Bidder. On the basis of this evaluation process, Authority will issue a Letter of Award (the "**LOA**") to the Selected Bidder.

- 2.2.3.** All Bidders are required to submit the Bid in accordance with the guidelines set forth in this RFP. In order to promote consistency among Bids and minimize potential

misunderstandings regarding how Bidders' Bids will be interpreted by the Authority, the format in which Bidders will specify the fundamental aspects of their Bids has been broadly outlined in this RFP.

2.2.4. The Bids, submitted by the Bidder, shall be valid for a period of not less than 120 days from the date specified in Clause 2.3 for submission of bids (the “**Bid Due Date**”).

2.2.5. **Extension of Bid Validity Period**

(a) In exceptional circumstances, if required, the Authority may request for one or more extensions of the Bid Validity Period to the Bidders. Such request to the Bidder (s) shall be made in writing prior to expiration of the Bid Validity Period. If any Bidder does not agree to the extension, it may withdraw its Bid without inviting action of forfeiture of its Bid Security by giving notice in writing to Authority of its decision prior to the expiration of the Bid Validity Period. The Bidder shall provide in writing its willingness to extend the Bid Validity Period as may be mutually agreed between the Authority and the Bidder from time to time.

(b) The Bid Validity Period of the selected Bidder shall be automatically extended till the date on which the Contract is executed and comes into force.

(c) When an extension of the Bid Validity Period is requested, Bidder(s) shall not be permitted to change the terms and conditions of their Bid(s).

2.2.6. The Bidding Documents include this RFP and Draft Contract for the Project which is enclosed. The aforesaid documents and any addenda issued subsequent to this RFP Document will be deemed to form part of the Bidding Documents.

2.2.7. A Bidder is required to deposit, along with Envelope I, a bid security of **INR 5,00,000/- (Indian Rupees Five Lakhs Only)** (the “**Bid Security**”), refundable not later than 180 (one hundred and eighty) days from the Bid Due Date, except in the case of the Selected Bidder whose Bid Security shall be retained till it has provided a Performance Security under the Contract. The Bidders will have to provide Bid Security in the form of a bank guarantee as per the format provided as part of the RFP document and the validity period of the bank guarantee shall not be less than 180 (one hundred and eighty) days from the Bid Due Date inclusive of a claim period of 60 (sixty) days, and may be extended as may be mutually agreed between the Authority and the Bidder from time to time. The Bid shall be summarily rejected if it is not accompanied by the Bid Security.

2.2.8. Bids are invited for the Project on the basis of the “**System Management Fee (the “System Management Fee” (SMF) per Bus per month to be paid by the Bidder to the Authority for the award of the Contract).** The Contract Period is pre-determined, as indicated in the Draft Contract. The “SMF” shall constitute the sole criteria for evaluation of Financial Bids. The Project will be awarded to the Bidder quoting the highest SMF.

In this RFP, the term “Highest Bidder” shall mean the Bidder who is offering the highest SMF.

2.2.9. Generally, the “**Highest Bidder**” shall be the Selected Bidder. The remaining Bidders shall be kept in reserve and may, in accordance with the process specified in Clauses 4.5.6.1 & 4.5.6.2 of this RFP, be invited to match the Bid submitted by the Highest Bidder, in case such Highest Bidder withdraws or is not selected for any reason. In the event that none of the other Bidders match the Bid of the Highest Bidder, the Authority may, in its sole discretion, reject the bids and invite fresh Bids from the remaining Bidders or annul the Bidding Process, as the case may be.

- 2.2.10. Any queries or request for additional information concerning this RFP shall be submitted in writing or by fax and e-mail to the officer designated in Clause 3.13.2 below. The envelopes/ communications shall clearly bear the following identification/ title:

- 2.2.11. Capitalized terms used in this RFP but not defined herein shall have the meaning ascribed to such terms in the Draft Contract.

2.3 Schedule of Bidding Process

SECTION - 3**INSTRUCTIONS TO BIDDERS****A. GENERAL****3.1 Scope of the Bids**

- 3.1.1 The Bidder may be a single entity or a group of entities (the “**Consortium**”), coming together to implement the Project. A Bidder bidding individually or as a member of a Consortium (the “**Consortium Member**”) shall not be entitled to submit another bid either individually or as a member of any Consortium, as the case maybe. The term Bidder used herein would apply to both a single entity and a Consortium.
- 3.1.2 To be eligible for consideration under this RFP, the Bidder shall be a company registered under the Companies Act, 1956/2013 or more than one company with a formal intent to enter into an agreement or under an existing agreement to form a Consortium. A Consortium shall be eligible for consideration subject to the conditions set out in Clause 3.2.2 below.
- 3.1.3 Notwithstanding anything to the contrary contained in this RFP, the detailed terms specified in the Draft Contract shall have overriding effect; provided, however, that any conditions or obligations imposed on the Bidder hereunder shall continue to have effect in addition to its obligations under the Draft Contract.
- 3.1.4 Any condition or criteria or any other stipulation contained in the Bid shall render the Bid liable to rejection.
- 3.1.5 The Bidder should submit a Power of Attorney as per the format at Appendix II, authorizing the signatory of the Bid to commit the Bidder.
- 3.1.6 In case the Bidder is a Consortium, the Members thereof should furnish a Power of Attorney in favour of the Lead Member in the format at Appendix III¹.
- 3.1.7 The documents including this RFP and all attached documents, provided by the Authority are and shall remain or become, the property of the Authority and are transmitted to the Bidders solely for the purpose of preparation and the submission of a Bid in accordance herewith. Bidders are required to treat all information as strictly confidential and shall not use it for any purpose other than for preparation and submission of their Bid. The provisions of this Clause 3.1.7 shall also apply mutatis mutandis to Bids and all other documents submitted by the Bidders, and the Authority will not return to the Bidders any Bid, document or any information provided along therewith.
- 3.1.8 This RFP is not transferable.
- 3.1.9 All numbers are to be provided in both numerical form and in words. If there is a discrepancy between the numbers written out in words and the numerical form, then the number expressed in words shall prevail.
- 3.1.10 The Bidder shall furnish as part of its Bid, a Bid Security in the form of an unconditional bank guarantee issued by a nationalized bank, or a Scheduled Bank in India having a net worth of at least INR 1,000 crore (Rupees One Thousand Crore), in favour of the Authority in the format at Appendix V (the “**Bank Guarantee**”) and having a validity period of not less than 180 (one hundred eighty) days from the Bid Due Date, inclusive of a claim period of 60 (sixty) days, and may be extended as may be mutually agreed between the Authority

and the Bidder from time to time. In case the Bank Guarantee is issued by a foreign bank outside India, confirmation of the same by any nationalized bank in India is required. For the avoidance of doubt, Scheduled Bank shall mean a bank as defined under Section 2(e) of the Reserve Bank of India Act, 1934. The Authority shall not be liable to pay any interest on the Bid Security deposit so made and the same shall be interest free.

3.1.11 By submitting its Bid, the Bidder, do hereby in terms of the RFP Document, irrevocably, unconditionally and without reservation guarantee the due and faithful fulfilment and compliance of the terms and conditions of the Bidding Documents (including the RFP Document) by the said Bidder and unconditionally and irrevocably undertakes to pay forthwith to the Authority the amount of Bid Security, as its primary obligation, without any demur, reservation, recourse, contest or protest if the Bidder shall fail to fulfil or comply with all or any of the terms and conditions contained in the said Bidding Documents. Any such written demand made by the Authority stating that the Bidder is in default of the due and faithful fulfilment and compliance with the terms and conditions contained in the Bidding Documents shall be final, conclusive and binding. The Bidder, by submitting its Bid pursuant to this RFP, shall be deemed to have acknowledged and confirmed that the Authority will suffer loss and damage on account of withdrawal of its Bid or for any other default by the Bidder during the period of Bid validity as specified in this RFP. No relaxation of any kind on Bid Security shall be given to any Bidder. Without prejudice to any other right or remedy that may be available to the Authority under the Bidding Documents and/ or under the Contract, or otherwise, the Authority shall also be entitled to forfeit and appropriate the Bid Security as damages inter alia in events specified herein below:

- (a) If a Bidder engages in a corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice as specified in Section 4 of this RFP;
- (b) If a Bidder withdraws its Bid during the period of Bid validity as specified in this RFP and as extended by mutual consent of the respective Bidder(s) and the Authority;
- (c) In the case of Selected Bidder, if it fails, within the specified time limit, to sign and return the duplicate copy of LOA or to sign the Contract or to furnish the Performance Security within the period prescribed therefor in the LOA and the Contract; or after having signed the Contract, commits any breach thereof prior to furnishing the Performance Security.

3.2 Eligibility of Bidders

3.2.1 For determining the eligibility of Bidder the following shall apply:

- (a) A Bidder shall not have a conflict of interest (the “**Conflict of Interest**”) that affects the Bidding Process. Any Bidder found to have a Conflict of Interest shall be disqualified. In the event of disqualification, the Authority shall be entitled to forfeit and appropriate the Bid Security or Performance Security, as the case may be, as mutually agreed genuine pre-estimated loss and damage likely to be suffered and incurred by the Authority and not by way of penalty for, inter alia, the time, cost and effort of the Authority, including consideration of such Bidder’s Bid (the “**Damages**”), without prejudice to any other right or remedy that may be available to the Authority under the Bidding Documents and/or the Contract or otherwise. A Bidder shall be deemed to have a Conflict of Interest affecting the Bidding Process, if:
 - i. the Bidder, its Member or Associate (or any constituent thereof) and any other Bidder, its Member or any Associate thereof (or any constituent thereof) have common controlling shareholders or other ownership interest; provided that this disqualification shall not apply in cases where the direct or indirect shareholding of a Bidder, its Member or an Associate thereof (or any shareholder thereof

- having a shareholding of not more than 5 per cent of the paid up and subscribed share capital of such Bidder, Member or Associate, as the case may be) in the other Bidder, its Member or Associate is not more than 5 per cent of the subscribed and paid up equity share capital thereof; provided further that this disqualification shall not apply to any ownership by a bank, insurance company, mutual fund, qualified foreign institutional investor, pension fund or a public financial institution referred to in section 2(72) of the Companies Act, 2013. For the purposes of this Clause 3.2.1(a), indirect shareholding held through one or more intermediate persons shall be computed as follows: (aa) where any intermediary is controlled by a person through management control or otherwise, the entire shareholding held by such controlled intermediary in any other person (the “**Subject Person**”) shall be taken into account for computing the shareholding of such controlling person in the Subject Person; and (bb) subject always to sub-clause (aa) above, where a person does not exercise control over an intermediary, which has shareholding in the Subject Person, the computation of indirect shareholding of such person in the Subject Person shall be undertaken on a proportionate basis; provided, however, that no such shareholding shall be reckoned under this sub-clause (bb) if the shareholding of such person in the intermediary is less than 26% of the subscribed and paid up equity shareholding of such intermediary; or
- ii. a constituent of such Bidder is also a constituent of another Bidder; or
 - iii. such Bidder, or any Associate thereof receives or has received any direct or indirect subsidy, grant, concessional loan or subordinated debt from any other Bidder, or any Associate thereof or has provided any such subsidy, grant, concessional loan or subordinated debt to any other Bidder, its Member or any Associate thereof; or
 - iv. such Bidder has the same legal representative for purposes of this Bid as any other Bidder; or
 - v. such Bidder, or any Associate thereof has a relationship with another Bidder, or any Associate thereof, directly or through common third party/ parties, that puts either or both of them in a position to have access to each other’s’ information about, or to influence the Bid of either or each other; or
 - vi. such Bidder, or any Associate thereof has participated as a consultant to the Authority in the preparation of any documents, design or technical specifications of the Project.
- (b) A Bidder shall be liable for disqualification and forfeiture of Bid Security if any legal, financial or technical adviser of the Authority in relation to the Project is engaged by the Bidder, its Member or any Associate thereof, as the case may be, in any manner for matters related to or incidental to the Project during the Bidding Process or subsequent to the (i) issue of the LOA or (ii) execution of the Contract. In the event any such adviser is engaged by the Selected Bidder or Operator, as the case may be, after issue of the LOA or execution of the Contract, then notwithstanding anything to the contrary contained herein or in the LOA or the Contract and without prejudice to any other right or remedy of the Authority, including the forfeiture and appropriation of the Bid Security or Performance Security, as the case may be, which the Authority may have thereunder or otherwise, the LOA or the Contract, as the case may be, shall be liable to be terminated without the Authority being liable in any manner whatsoever to the Selected Bidder or Operator for the same. For the avoidance of doubt, this disqualification shall not apply where such adviser was engaged by the Bidder, its Member or Associate in the past but its assignment expired or was terminated 6 (six) months prior to the date of issue of this RFP. Nor will this disqualification apply where such adviser is engaged after a period of 6 (six) months from the COD .

Explanation: In case a Bidder is a Consortium, then the term Bidder as used in this Clause 3.2.1, shall include each Member of such Consortium.

For purposes of this RFP, Associate means, in relation to the Bidder/consortium member (the “**Consortium Member**” or “**Member**”), a person who controls, is controlled by, or is under the common control with such Bidder/ Consortium Member (the “**Associate**”). As used in this definition, the expression “control” means, with respect to a person which is a company or corporation, the ownership, directly or indirectly, of more than 50% (fifty percent) of the voting shares of such person, and with respect to a person which is not a company or a corporation, the power to direct the management and policies of such person by operation of law.

3.2.2 To be eligible for opening of Financial Bid, a Bidder shall fulfil the following conditions of eligibility (the “**Eligibility Criteria**”) :

- (A) **Technical Capacity:** For demonstrating technical capacity and experience (the “**Technical Capacity**”), the Bidder shall have:
- i. minimum 2 (two) years of experience in operating and managing Intra City Bus Transport Services to Public Sector Entity / Government or Semi Government Department preceding the Bid Due Date.
 - ii. experience in operation of at least 100 (One Hundred) Standard / Midi Buses over the past 2 (two) Financial Years preceding the Bid Due Date for Intra City Bus Transport Services to Public Sector Entity / Government or Semi Government Department on PPP (Rental or Licensee mode).
 - iii. IT Solution experience for Intra City Bus Transport Services to Public Sector Entity / Government or Semi Government Department for Standard / Midi Buses over the past 2 (two) Financial Years preceding the Bid Due Date in:
 - a. deploying at least 50 (Fifty) Electronic Ticket Issuance Machine (ETIM)
 - b. providing Mobile app-based Bus tracking and ticketing solution with minimum 1,00,000 download.
 - c. deploying at least 50 (Fifty) GPS based bus tracking system
 - d. providing Smartcard based ticketing for at least 50 (fifty) Standard / Midi Buses.

For the avoidance of doubt, Operation Experience must include integrated planning & scheduling, managing and monitoring of day to day intra city bus operations and maintenance. The Operational experience must be demonstrated through a permit/Licence or an Agreement of operations with a Public Sector Entity / Government or Semi Government Department.

- (B) **Financial Capacity:** For demonstrating financial capacity and experience (the “**Financial Capacity**”), the Bidder shall have:
- i. Minimum Net Worth (the “**Net Worth**”) of INR 1.50 Crore (Indian Rupees One Crore and Fifty Lakh Only) at the close of the preceding financial year;
 - ii. Minimum Average Annual Turnover equivalent to INR 2.50 Crore (Indian Rupees Two Crore and Fifty Lakh Only) in the immediately preceding last 2 (two) Financial years.

In case of a Consortium, the combined technical capacity and financial capacity of those Members, who have and shall continue to have an equity share of at least 26% (twenty six per cent) each in the SPV as committed in the **Jt. Bidding Agreement**, should satisfy the above conditions of eligibility; provided that each such Member shall, for a period till the Expiry Date in terms of the Contract, hold equity share

capital not less than: (i) 26% (twenty six per cent) of the subscribed and paid up equity of the SPV; and (ii) 5% (five per cent) of the Estimated Project Cost specified in the Contract.

- 3.2.3 **Associates:** In computing the Technical Capacity and Financial Capacity of the Bidder/Consortium Members under Clause 3.2.2, the Technical Capacity and Financial Capacity of their respective Associates would also be eligible hereunder.
- 3.2.4 The Bidder shall enclose with its Bid, to be submitted as per the format at Appendix I, complete with its Annexes, the following :
- (i) certificate (s) from its statutory auditors specifying the net worth of the Bidder at the close of the preceding financial year. For the purposes of this RFP, net worth (the “**Net Worth**”) shall mean the aggregate value of the paid-up share capital and all reserves created out of the profits and securities premium account, after deducting the aggregate value of the accumulated losses, deferred expenditure and miscellaneous expenditure not written off, as per the audited balance sheet, but does not include reserves created out of revaluation of assets, write-back of depreciation and amalgamation;
 - (ii) documentary evidence towards proof of operations in respect of which experience is being claimed by the Bidder under Technical Capacity as per the format given in Appendix VI (A&B) & Appendix VII; and
 - (iii) copies of Bidder’s duly audited balance sheet and profit and loss account for the preceding 2 (two) years towards proof of minimum average annual turnover.
- 3.2.5 Whether the Selected Bidder is a single entity or a Consortium, it shall be required to form an appropriate Special Purpose Vehicle, incorporated under the Companies Act, 2013 (the “**SPV**”) to execute the Contract and implement the Project. In case the Selected Bidder is a Consortium then it shall in addition to forming an SPV, comply with the following additional requirements:
- a. Number of members in a consortium shall not **exceed 3 (three)**;
 - b. the Bid should contain the information required for each member of the consortium;
 - c. members of the Consortium shall nominate one member as the lead member (the “**Lead Member**”), who shall have an equity share holding of at least 26% (twenty six per cent) of the paid up and subscribed equity of the SPV. The nomination(s) shall be supported by a Power of Attorney, as per the format prescribed in this RFP, signed by all the other members of the Consortium^{II};
 - d. the Bid should include a brief description of the roles and responsibilities of individual members, particularly with reference to financial, technical and operation & maintenance obligations;
 - e. an individual Bidder cannot at the same time be member of a Consortium applying for selection. Further, a member of a particular Bidder Consortium cannot be member of any other Bidder Consortium applying for selection;
 - f. the members of a Consortium shall form an appropriate SPV to execute the Project, if awarded to the Consortium;
 - g. members of the Consortium shall enter into a binding Joint Bidding Agreement, substantially in the format at Appendix IV (the “**Jt. Bidding Agreement**”), for the

purpose of submitting the Bid. The Jt. Bidding Agreement, to be submitted along with the Bid, shall, inter alia:

- i. convey the intent to form an SPV with shareholding/ ownership equity commitment(s) in accordance with this RFP, which would enter into the Contract and subsequently perform all the obligations of the Operator in terms of the Contract, in case the Project is awarded to the Consortium;
 - ii. clearly outline the proposed roles and responsibilities, if any, of each member;
 - iii. commit the minimum equity stake to be held by each member;
 - iv. commit that each of the members, whose experience will be evaluated for the purposes of this RFP, shall subscribe to minimum 26% (twenty six per cent) or more of the paid up and subscribed equity of the SPV and shall further commit that each such member shall, till the Expiry Date, hold equity share capital not less than: (i) 26% (twenty six per cent) of the subscribed and paid up equity share capital of the SPV; and (ii) 5% (five per cent) of the Estimated Project Cost specified in the Contract;
 - v. members of the Consortium undertake that they shall collectively themselves or together with their Associates hold at least 51% (fifty one per cent) of the subscribed and paid up equity of the SPV at all times until the Expiry Date;
 - vi. include a statement to the effect that all members of the Consortium shall be liable jointly and severally for all obligations of the Operator in relation to the Project; and
- h. except as provided under the Bidding Documents, there shall not be any amendment to the Jt. Bidding Agreement without the prior written consent of the Authority.
- i. By submitting the Bid, the Bidder shall also be deemed to have acknowledged and agreed that in the event of a change in control of a Member of a Consortium or an Associate whose Technical Capacity and/ or Financial Capacity is taken into consideration for the purposes of evaluation, the Bidder shall inform the Authority forthwith along with all relevant particulars about the same and the Authority may, in its sole discretion, disqualify the Bidder or withdraw the LOA from the Selected Bidder, as the case may be.

3.2.6 Any entity which has been barred by the Central/State Government, or any entity controlled by it, from participating in any project, and the bar subsists as on the date of Bid, would not be eligible to submit a Bid, either individually or as member of a Consortium.

3.2.7 A Bidder including any Consortium Member or Associate should, in the **last 3 (three) years**, have neither failed to perform on any contract, as evidenced by imposition of a penalty by an arbitral or judicial authority or a judicial pronouncement or arbitration award against the Bidder, Consortium Member or Associate, as the case may be, nor has been expelled from any project or contract by any public entity nor have had any contract terminated any public entity for breach by such Bidder, Consortium Member or Associate.

3.2.8 The following conditions shall be adhered to while submitting a Bid:

- a. Bidders should attach clearly marked and referenced continuation sheets in the event that the space provided in the prescribed forms in the Annexes is insufficient. Alternatively, Bidders may format the prescribed forms making due provision for incorporation of the requested information;
- b. information supplied by a Bidder (or other constituent Member if the Bidder is a Consortium) must apply to the Bidder, Member or Associate named in the Bid and not, unless specifically requested, to other associated companies or firms;

- c. in responding to the selection submissions, Bidders should demonstrate their capabilities in accordance with Clause 4.1 below; and
- d. in case the Bidder is a Consortium, each Member should substantially satisfy the selection requirements to the extent specified herein.

3.3 Change in composition of the Consortium

- 3.3.1 Change in the composition of a Consortium will not be permitted by the Authority during the Bid Process.
- 3.3.2 Notwithstanding anything to the contrary contained in Clause 3.3.1, a Bidder may, within 10 (ten) days after the Bid Due Date, remove from its Consortium any Member who suffers from a Conflict of Interest, and such removal shall be deemed to cure the Conflict of Interest arising in respect thereof. Provided however, pursuant to removal of such Member, the Consortium should continue to fulfil the eligibility criteria as stipulated in this RFP Document.

3.4 Number of Bids and costs thereof

- 3.4.1 No Bidder shall submit more than one Bid for the Project. A Bidder applying individually or as a member of a Consortium shall not be entitled to submit another bid either individually or as a member of any Consortium, as the case may be.
- 3.4.2 The Bidder shall be responsible for all of the costs associated with the preparation of their Bids and their participation in the Bid Process. The Authority will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process.

3.5 Site Visit and verification of information

Bidders are encouraged to submit their respective bids after visiting the Project site and ascertaining for themselves the ridership, traffic and road conditions, availability of power, water and other utilities at the Bus Depot, applicable laws and regulations, and any other matter considered relevant by them, at their own cost.

3.6 Acknowledgement by Bidder

- 3.6.1 It shall be deemed that by submitting the Bid, the Bidder has:
 - a. made a complete and careful examination of the RFP;
 - b. received all relevant information requested from the Authority;
 - c. accepted the risk of inadequacy, error or mistake in the information provided in the RFP or furnished by or on behalf of the Authority relating to any of the matters referred to in Clause 3.5 above; and
 - d. agreed to be bound by the undertakings provided by it under and in terms hereof.
- 3.6.2 The Authority shall not be liable for any omission, mistake or error in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to the RFP or the Bidding Process, including any error or mistake therein or in any information or data given by the Authority.

3.7 Right to Accept or reject any or all Bids

- 3.7.1 Notwithstanding anything contained in this RFP, the Authority reserves the right to accept or reject any Bid and to annul the Bidding Process and reject all Bids, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons thereof. In the event that the Authority rejects or annuls all the Bids, it may, in its discretion, invite all eligible Bidders to submit fresh Bids hereunder.

- 3.7.2 The Authority reserves the right to reject any Bid if:
- at any time, a material misrepresentation is made or uncovered, or
 - the Bidder does not provide, within the time specified by the Authority, the supplemental information sought by the Authority for evaluation of the Bid.

If the Bidder is a Consortium, then the entire Consortium may be disqualified/ rejected. If such disqualification/ rejection occurs after the bids have been opened and the “Highest Bidder” gets disqualified/ rejected, then the Authority reserves the right to:

- invite the remaining Bidders to match the Highest Bidder to submit their Bids in accordance with Clauses 4.5.8 and 4.5.7 of the RFP; or
 - take any such measure as may be deemed fit in the sole discretion of the Authority, including annulment of the Bidding Process.
- 3.7.3 In case it is found during the evaluation or at any time before signing of the Contract or after its execution and during the period of subsistence thereof, that one or more of the selection criteria have not been met by the Bidder, or the Bidder has made material misrepresentation or has given any materially incorrect or false information, the Bidder shall be disqualified forthwith if not yet appointed as the Operator either by issue of the LOA or entering into the Contract, and if the Bidder/SPV has already been issued the LOA or has entered into the Contract, as the case may be, the same shall, notwithstanding anything to the contrary contained therein or in this RFP, be liable to be terminated, by a communication in writing by the Authority to the Bidder, without the Authority being liable in any manner whatsoever to the Bidder and without prejudice to any other right or remedy which the Authority may have under this RFP, the Bidding Documents, the Contract or under Applicable Law. In such an event, the Authority shall forfeit and appropriate the Bid Security or Performance Security, as the case may be, as mutually agreed genuine pre-estimated compensation and damages payable to the Authority for, inter alia, time, cost and effort of the Authority, without prejudice to any other right or remedy that may be available to the Authority.
- 3.7.4 The Authority reserves the right to verify all statements, information and documents submitted by the Bidder in response to the RFP. Any such verification or lack of such verification by the Authority shall not relieve the Bidder of its obligations or liabilities hereunder nor will it affect any rights of the Authority thereunder.

B. DOCUMENTS

3.8 Contents of the Bidding Document

The Bidding Documents consists of two separate documents as listed below and would include any Addenda issued in accordance with Clause 3.10.

3.9 Clarifications

- 3.9.1 Bidders requiring any clarification on the RFP may notify the Authority in writing or by fax and e-mail in accordance with Clause 2.2.10. They should send in their queries before the date specified in the schedule of Bidding Process contained in Clause 2.3. The Authority shall endeavour to respond to the queries within the period specified therein, but no later than 10 (ten) days prior to the Bid Due Date. The responses will be sent by fax

and/or e-mail. The Authority will publish all the queries and its responses thereto on its website.

- 3.9.2 The Authority shall endeavour to respond to the questions raised or clarifications sought by the Bidders. However, the Authority reserves the right not to respond to any question or provide any clarification, in its sole discretion, and nothing in this Clause 3.9.2 shall be taken or read as compelling or requiring the Authority to respond to any question or to provide any clarification.
- 3.9.3 The Authority may also on its own motion, if deemed necessary, issue interpretations and clarifications to all Bidders. All clarifications and interpretations issued by the Authority shall be deemed to be part of the RFP. Verbal clarifications and information given by Authority or its employees or representatives shall not in any way or manner be binding on the Authority.

3.10 Amendment of RFP

- 3.10.1 At any time prior to the deadline for submission of Bid, the Authority may, for any reason, whether at its own initiative or in response to clarifications requested by the Bidder, modify the RFP by the issuance of Addenda.
- 3.10.2 Any Addendum thus issued will be published on Authority's website.
- 3.10.3 In order to afford the Bidders a reasonable time for taking an Addendum into account, or for any other reason, the Authority may, in its sole discretion, extend the Bid Due Date.

C. PREPARATION AND SUBMISSION OF BID

3.11 Language

The Bid and all related correspondence and documents in relation to the Bidding Process shall be in English language. Supporting documents and printed literature furnished by the Bidder with the Bid may be in any other language provided that they are accompanied by translations of all the pertinent passages in the English language, duly authenticated and certified by the Bidder. Supporting materials, which are not translated into English, may not be considered. For the purpose of interpretation and evaluation of the Bid, the English language translation shall prevail.

3.12 Format & Signing of Bid

- 3.12.1 The Bidder shall provide all the information sought under this RFP. The Authority will evaluate only those Bids that are received in the required formats and complete in all respects. Incomplete and /or conditional Bids shall be liable to rejection.
- 3.12.2 The Bidder shall prepare 1 (one) original set of the Bid (together with originals/ copies of documents required to be submitted along therewith pursuant to this RFP) and clearly marked "ORIGINAL". In addition, the Bidder shall submit 1 (one) copy each of the Test of Responsiveness and the Technical Bid, along-with documents required to be submitted along therewith pursuant to this RFP, marked "COPY". The Bidder shall also provide 2 (two) soft copies of the Test of Responsiveness and the Technical Bid on Compact Disc (CD). In the event of any discrepancy between the original and the copy, the original shall prevail.
- 3.12.3 The Bid and its copy shall be typed or written in indelible ink and signed by the authorized signatory of the Bidder who shall also initial each page, in blue ink. In case of printed and published documents, only the cover shall be initialled. All the alterations, omissions, additions or any other amendments made to the Bid shall be initialled by the person(s) signing the Bid.

3.13 Sealing & Marking of Bids

3.13.1 The Bidder shall submit the Bid in the format as specified in this RFP bound together along with all the relevant documents as specified in Clause 3.14 below, in three separate envelopes duly marked as:

- “Envelope 1 – Test of Responsiveness”;
- “Envelope 2 – Technical Bid”; and
- “Envelope 3 – Financial Bid”

Envelopes 1 and 2 shall contain the original and the copy of the documents to be submitted, together with their respective enclosures, in separate envelopes duly marking the envelopes as “ORIGINAL” and “COPY” and sealed in an outer envelope and mark the outer envelope as stated above.

All the three envelopes shall then be sealed in the main outer envelope marked as “Bid for **Selection of Operator for Intra City Bus Services on identified routes at Patna on Procure, Operate and Maintain basis through PPP Mode: Net Cost Contract**”. In addition, the Bid Due Date should be indicated on the right hand corner of each of the envelopes.

3.13.2 Each of the envelopes shall be addressed to:

3.13.3 If the envelopes are not sealed and marked as instructed above, the Authority assumes no responsibility for the misplacement or premature opening of the contents of the Bid and consequent losses, if any, suffered by the Bidder.

3.13.4 Bids submitted by fax, telex, telegram or e-mail shall not be entertained and shall be rejected.

3.14 Contents of the Bid

The Bid shall be submitted in the following 3 separate envelopes:

“Envelop 1: Test of Responsiveness” which will consist of documents the details of which are mentioned in Clause 3.14.1;

“Envelop 2: Technical Bid” which will consist of documents the details of which are mentioned in Clause 3.14.2; and

“Envelop 3: Financial Bid” which will consist of documents the details of which are mentioned in Clause 3.14.3.

3.14.1 Envelope 1: Test of Responsiveness: It shall consist of:

- (i) Letter comprising the application for Qualification of Bid (**Appendix I**) along with Annexes;
- (ii) Power of Attorney for signing the Bid as per the format at **Appendix II**;
- (iii) In case of Consortium, the Power of Attorney for Lead Member of Consortium as per the format at **Appendix III**;

- (iv) Jt. Bidding Agreement, in case of a Consortium, in the format at **Appendix IV**;
- (v) Bid Security in the form of Bank Guarantee which shall be in the format at **Appendix V** in the favour of Bihar State Road Transport Corporation;
- (vi) Copy of Memorandum and Articles of Association of the Bidder;
- (vii) Copy of authority letter/Board Resolution, authorizing the Authorized Signatory to sign the Bid; and
- (viii) Cost of Bidding Documents or proof of payment thereof, in case already paid;

3.14.2 Envelope 2: Technical Bid: The Technical Bid shall consist of:

- (i) Technical Capacity of the Bidder specifying experience in operating and managing Intra City Bus Transport Services to Public Sector Entity / Government or Semi Government Department in the prescribed format (**Appendix VI A&B**) along with requisite supporting documents as specified;
- (ii) Copies of Bidder's duly audited balance sheet and profit and loss account for the preceding 2 (two) years along with a certificate from the statutory auditor specifying the net worth of the Bidder at the close of the preceding financial year;
- (iii) Technical Capacity of the Bidder specifying experience in IT solution for Intra City Bus Transport Services to Public Sector Entity / Government or Semi Government Department in the prescribed format (**Appendix VII**) along with requisite supporting documents as specified;
- (iv) Financial Capacity of the Bidder in the prescribed format (**Appendix VIII**) along with requisite documents as specified; and

3.14.3 Envelope 3: Financial Bid: The Financial Bid shall consist of:

- (i) The Financial Bid in the prescribed format (Appendix IX)

3.14.4 All the 3 envelopes along with the aforesaid documents shall be sealed separately and then put together in one single outer envelope and marked as specified in Clause 3.13 above.

3.15 Bid Due Date

- 3.15.1 Bids should be submitted before 1500 hours IST on the Bid Due Date, at the address provided in Clause 3.13.2 in the manner and form as detailed in this RFP. A receipt thereof should be obtained from the person specified in Clause 3.13.2.
- 3.15.2 The Authority may, in its sole discretion, extend the Bid Due Date by issuing an Addendum in accordance with Clause 3.10 uniformly for all Bidders.

3.16 Late Bids

Bids received by the Authority after the specified time on the Bid Due Date shall not be eligible for consideration and shall be summarily rejected.

3.17 Modifications / substitution / withdrawal of Bids

- 3.17.1 The Bidder may modify, substitute or withdraw its Bid after submission, provided that written notice of the modification, substitution or withdrawal is received by the Authority prior to the Bid Due Date. No Bid shall be modified, substituted or withdrawn by the Bidder on or after the Bid Due Date.
- 3.17.2 The modification, substitution or withdrawal notice shall be prepared, sealed, marked, and delivered in accordance with Clause 3.13, with the envelopes being additionally marked "MODIFICATION", "SUBSTITUTION" or "WITHDRAWAL", as appropriate.

- 3.17.3 Any alteration/modification in the Bid or additional information supplied subsequent to the Bid Due Date, unless the same has been expressly sought for by the Authority, shall be disregarded.

3.18 Proprietary Data

All documents and other information supplied by the Authority or submitted by a Bidder to the Authority shall remain or become the property of the Authority. Bidders are to treat all information as strictly confidential and shall not use it for any purpose other than for preparation and submission of their Bid. The Authority will not return any Bid or any information provided along therewith.

3.19 Correspondence with the Bidder

Save and except as provided in this RFP, the Authority shall not entertain any correspondence with any Bidder in relation to the acceptance or rejection of any Bid.

SECTION - 4**EVALUATION CRITERIA****4.1 Evaluation parameters**

- 4.3.3 Only those Bidders who meet the eligibility criteria specified in Clause 3.2.2 above shall qualify for evaluation under this Section 4. Bids of firms/consortia who do not meet these criteria shall be rejected.
- 4.3.4 The Bidder's competence and capability is proposed to be established by the following parameters:
- (a) Technical Capacity; and
 - (b) Financial Capacity

4.2 Technical Capacity for purposes of evaluation

- 4.2.1. The Bidder must provide the documentary evidence validating the information provided in Appendix VI A&B & Appendix VII.
- 4.2.2. The Authority shall not evaluate the experience if no supporting documents are submitted by the Bidder validating all the information mentioned in Appendix VI A&B & Appendix VII.

4.3 Details of Experience

- 4.3.1. The Bidder should furnish the details of experience for the last 2 (two) financial years preceding the Bid Due Date.
- 4.3.2. The Bidders must provide the necessary information relating to Technical Capacity as per format at Appendix VI A&B & Appendix VII along with requisite supporting documents as specified.

4.4 Financial information for purposes of evaluation

- 4.4.1. The Bid must be accompanied by the Audited Annual Reports of the Bidder (of each Member in case of a Consortium) for the last 2 (two) financial years preceding the Bid Due Date.

For the avoidance of doubt, it is clarified that the 'last 2 (two) years preceding the Bid Due Date' for the purpose of this RFP shall be determined as under:

- Year 1 will be the latest financial year which was completed at least three months prior to the Bid Due Date;
- Year 2 shall be the financial year immediately preceding Year 1; and so on

For example, in case the Bid Due Date falls in July 2020 and the Financial Year of the Bidder is April to March, then the Year 1 shall, for the above purposes, be April 2019 to March 2020.

- 4.4.2. In case the annual accounts for the latest financial year completed at least three months prior to the Bid Due Date are not audited and therefore the Bidder cannot make it available, the Bidder shall give an undertaking to this effect and the statutory auditor shall certify the same. In such a case, the Bidder shall provide the Audited Annual Reports for 2 (two) years preceding the year for which the Audited Annual Report is not being provided. In such case, the 'last 2 (two) years preceding the Bid Due Date' as determined in terms of 4.5.1, shall deem to start from the latest financial year from which the Audited Annual Reports has been provided by the Bidder.

- 4.4.3. The Bidder must establish the Net Worth and Turnover as specified in Clause 3.2.2 (B), and provide details as per format at Appendix VIII along with an Auditor’s Certificate specifying the net worth of the Bidder at the close of the preceding financial year. The Bidder shall also provide copies of Bidder’s duly audited balance sheet and profit and loss account for the preceding 2 (two) years.

4.5 Opening and Evaluation of Bids

- 4.5.1. The Authority shall open the Bids at 1530 hours IST on the Bid Due Date, at the place specified in Clause 3.13.2 and in the presence of the Bidders who choose to attend.
- 4.5.2. Bids for which a notice of withdrawal has been submitted in accordance with Clause 3.17 shall not be opened.
- 4.5.3. The Bids received would be subject to a prima-facie check for responsiveness followed by a step-wise evaluation procedure as described below.

4.5.4. STEP 1 (Envelop – 1): Responsiveness of Bid

As the first step, Envelope-1 (the “**Test of Responsiveness**”) shall be opened for evaluation. Prior to detailed evaluation, the Authority shall determine whether each Bid is responsive to the requirements of the RFP. A Bid shall be considered responsive only if:

- a. it is received by the **Bid Due Date** including any extension thereof pursuant to Clause 3.10.3;
- b. it is signed, sealed, **bound together**, and marked as stipulated in Clause 3.13.1;
- c. it is accompanied by the **Power of Attorney** as specified in Clause 3.1.5, and in the case of a Consortium, the Power of Attorney as specified in Clause 3.1.6;
- d. it is accompanied by the **Jt. Bidding Agreement** (for Consortium), specific to the Project, as stipulated in Clause 3.2.1(g);
- e. it is accompanied by a copy of **Board Resolution/ authority letter** authorizing the Authorized Signatory for signing the Bid. In case the Bidder is a Consortium, each of the Consortium shall provide separate Board Resolution/authority letter authorizing the Lead Member to submit the Bid on its behalf;
- f. it contains the **Statement of Legal Capacity** as Annex II to Appendix I;
- g. it contains a Demand Draft of INR 5,000/- (Indian Rupees Five Thousand Only) or an attested copy of the receipt for payment of INR 5,000/- (Indian Rupees Five Thousand Only) to Authority, if already paid, towards the **cost of the RFP document**;
- h. it contains a valid **Bid Security**;
- i. it contains information as regards qualification as per the prescribed format;
- j. it has the **minimum qualification** as required in terms of Clause 3.2.2;
- k. it does not contain any condition or criteria; and
- l. it is not non-responsive in terms hereof.

The Bid shall be considered to be responsive if it conforms to the preceding requirements without any deviation or reservation. The Authority reserves the right to reject any Bid which is non-responsive and no request for alteration, modification, substitution or withdrawal shall be entertained in respect of such Bids.

The Bids of “Responsive” Bidders shall be evaluated in the following steps:

4.5.5. **STEP 2 (Envelop – 2): Evaluation of Technical & Financial Capacity**

In this stage, the Technical and Financial Capacity of the Bidders in undertaking the Project would be assessed. The Bidders would be evaluated on the Eligibility Criteria as defined in Clause 3.2.2 and Section 4, and the Bidders found to be technically and financially qualified would be eligible for the next stage of the selection process. The Financial Bid (Envelope-3) of the Bidders not found to be technically and financially qualified would not be opened and returned back to such Bidders unopened.

4.5.6. **STEP 3 (Envelop – 3): Evaluation of Financial Bid**

Financial Bid of those Bidders whose Technical Bid meet the technical and financial capability requirements as set out in Clause 3.2.2 and 4.1 would be opened and evaluated in the 3rd Step of Evaluation Process, in the presence of the Bidders' representatives who choose to attend

The Bidder who quotes the highest SMF shall be declared as the Selected Bidder (the “**Selected Bidder**”). In the event that the Authority rejects or annuls all the Bids, it may, in its discretion, invite all eligible Bidders to submit fresh Bids hereunder.

- 4.5.6.1. In the event that two or more Bidders quote the same amount of SMF which emerges as the Highest Bid (the “**Tie Bidders**”), the Authority shall invite the Tie Bidders to quote revised Financial Bid, which shall under no circumstances be less/more than the Highest Bid received in the original Financial Bid.
- 4.5.6.2. In the event that the Highest Bidder withdraws or is not selected for any reason in the first instance (the “**first round of bidding**”), the Authority may invite all the remaining eligible Bidders to revalidate or extend their respective Bid Security, as necessary, and match the Bid of the aforesaid Highest Bidder (the “**second round of bidding**”). If in the second round of bidding, only one Bidder matches the Highest Bidder, it shall be the Selected Bidder. If two or more Bidders match the said Highest Bidder in the second round of bidding, then the Bidder whose Bid was higher as compared to other Bidder(s) in the first round of bidding shall be the Selected Bidder. For example, if the third and fifth Highest Bidders in the first round of bidding offer to match the said Highest Bidder in the second round of bidding, the said third Highest Bidder shall be the Selected Bidder.
- 4.5.7. In the event that no Bidder offers to match the Highest Bidder in the second round of bidding as specified in Clause 4.5.6.2, the Authority may, in its discretion, invite fresh Bids (the “**third round of bidding**”) from all Bidders except the Highest Bidder of the first round of bidding, or annul the Bidding Process, as the case may be. In case the Bidders are invited in the third round of bidding to revalidate or extend their Bid Security, as necessary, and offer fresh Bids, they shall be eligible for submission of fresh Bids provided, however, that in such third round of bidding only such Bids shall be eligible for consideration which are higher than the Bid of the second Highest Bidder in the first round of bidding.
- 4.5.8. After selection, a Letter of Award (the “**LOA**”) shall be issued, in duplicate, by the Authority to the Selected Bidder and the Selected Bidder shall, within 7 (seven) days of the receipt of the LOA, sign and return the duplicate copy of the LOA in acknowledgement thereof. In the event the duplicate copy of the LOA duly signed by the Selected Bidder is not received by the stipulated date, the Authority may, unless it consents to extension of time for submission thereof, appropriate the Bid Security of such Bidder as mutually agreed genuine pre-estimated loss and damage suffered by the Authority on account of failure of the Selected Bidder to acknowledge the LOA, and the next eligible Bidder may be considered.

- 4.5.9. After acknowledgement of the LOA as aforesaid by the Selected Bidder, the Selected Bidder shall incorporate Special Purpose Vehicle (SPV), a company as per the provisions of Companies Act, 2013 with the exclusive object of operation and maintenance of the Project and to execute the Contract within the period prescribed in Clause 2.3. The Selected Bidder/Operator shall not be entitled to seek any deviation in the Contract.

4.6 Other Conditions

- 4.8.3 Bidders are advised that selection of Bidders will be entirely at the discretion of the Authority. Bidders will be deemed to have understood and agreed that no explanation or justification on any aspect of the Bidding Process or selection will be given.
- 4.8.4 Any information contained in the Bid shall not in any way be construed as binding on the Authority, its agents, successors or assigns, but shall be binding against the Bidder if the Project is subsequently awarded to it on the basis of such information.
- 4.8.5 The Authority reserves the right not to proceed with the Bidding Process at any time without notice or liability and to reject any or all Bid(s) without assigning any reasons.
- 4.8.6 If any information furnished by the Bidder is found to be incomplete, or contained in formats other than those specified herein, the Authority may, in its sole discretion, exclude the relevant project from the evaluation/ score of the Bidder.
- 4.8.7 In the event that the Bidder claims credit for a Project, and such claim is determined by the Authority as incorrect or erroneous, the Authority shall reject such claim and exclude the same from computation of the evaluation/ score, and may also, while computing the aggregate score of the Bidder, make a further deduction equivalent to the claim rejected hereunder. Where any information is found to be patently false or amounting to a material misrepresentation, the Authority reserves the right to reject the Bid in accordance with the provisions of Clauses 3.7.2 and 3.7.3.

4.7 Confidentiality

Information relating to the examination, clarification, evaluation, and recommendation for the selection shall not be disclosed to any person who is not officially concerned with the process or is not a retained professional advisor advising the Authority in relation to or matters arising out of, or concerning the Bidding Process. The Authority will treat all information, submitted as part of Bid, in confidence and will require all those who have access to such material to treat the same in confidence. The Authority may not divulge any such information unless it is directed to do so by any statutory entity that has the power under law to require its disclosure or is to enforce or assert any right or privilege of the statutory entity and/ or the Authority or as may be required by law or in connection with any legal process.

4.8 Clarifications

- 4.8.1 To facilitate evaluation of Bids, the Authority may, at its sole discretion, seek clarifications from any Bidder regarding its Bid. Such clarification(s) shall be provided within the time specified by the Authority for this purpose. Any request for clarification(s) and all clarification(s) in response thereto shall be in writing.
- 4.8.2 If the Bidder does not provide clarifications sought under Clause 4.8.1 above within the prescribed time, its Bid shall be liable to be rejected. In case the Bid is not rejected, the Authority may proceed to evaluate the Bid by construing the particulars requiring clarification to the best of its understanding, and the Bidder shall be barred from subsequently questioning such interpretation of the Authority.

SECTION - 5**FRAUD AND CORRUPT PRACTICES**

- 5.1. The Bidders and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Bidding Process. Notwithstanding anything to the contrary contained herein or in the LOA or the Contract, the Authority shall reject a Bid, withdraw the LOA, or terminate the Contract, as the case may be, without being liable in any manner whatsoever to the Bidder if it determines that the Bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice in the Bidding Process. In such an event, the Authority shall forfeit and appropriate the Bid Security or Performance Security, as the case may be, as mutually agreed genuine pre-estimated compensation and damages payable to the Authority towards, inter alia, time, cost and effort of the Authority, without prejudice to any other right or remedy that may be available to the Authority hereunder or otherwise.
- 5.2. Without prejudice to the rights of the Authority under Clause 5.1 hereinabove and the rights and remedies which the Authority may have under the LOA or the Contract, if a Bidder or Operator, as the case may be, is found by the Authority to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Bidding Process, or after the issue of the LOA or the execution of the Contract, such Bidder or Operator shall not be eligible to participate in any tender or RFP issued by the Authority during a period of 2 (two) years from the date such Bidder or Operator, as the case may be, is found by the Authority to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practices, as the case may be.
- 5.3. For the purposes of this Clause 5, the following terms shall have the meaning hereinafter respectively assigned to them:
- (a) **“corrupt practice”** means (i) the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the actions of any person connected with the Bidding Process (for avoidance of doubt, offering of employment to, or employing, or engaging in any manner whatsoever, directly or indirectly, any official of the Authority who is or has been associated in any manner, directly or indirectly, with the Bidding Process or the LOA or has dealt with matters concerning the Contract or arising therefrom, before or after the execution thereof, at any time prior to the expiry of one year from the date such official resigns or retires from or otherwise ceases to be in the service of the Authority, shall be deemed to constitute influencing the actions of a person connected with the Bidding Process); or (ii) save and except as permitted under sub clause (b) of Clause 3.2.1, engaging in any manner whatsoever, whether during the Bidding Process or after the issue of the LOA or after the execution of the Contract, as the case may be, any person in respect of any matter relating to the Project or the LOA or the Contract, who at any time has been or is a legal, financial or technical adviser of the Authority in relation to any matter concerning the Project;
 - (b) **“fraudulent practice”** means a misrepresentation or omission of facts or suppression of facts or disclosure of incomplete facts, in order to influence the Bidding Process;
 - (c) **“coercive practice”** means impairing or harming, or threatening to impair or harm, directly or indirectly, any person or property to influence any person’s participation or

action in the Bidding Process;

- (d) “**undesirable practice**” means (i) establishing contact with any person connected with or employed or engaged by the Authority with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Bidding Process; or (ii) having a Conflict of Interest; and
- (e) “**restrictive practice**” means forming a cartel or arriving at any understanding or arrangement among Bidders with the objective of restricting or manipulating a full and fair competition in the Bidding Process.

SECTION - 6

PRE-BID CONFERENCE

- 6.1. A Pre-Bid conference of the interested parties shall be convened at the designated date, time and place. Bidders who have downloaded the RFP document from the Authority's website www.transport.bih.nic.in, submit a Demand Draft of INR 5,000/- (Indian Rupees Five Thousand Only) towards the cost of document, through their representative attending the conference. A maximum of two representatives of each Bidder shall be allowed to participate on production of authority letter from the Bidder.
- 6.2. During the course of Pre-Bid conference, the Bidders will be free to seek clarifications and make suggestions for consideration of the Authority. The Authority shall endeavour to provide clarifications and such further information as it may, in its sole discretion, consider appropriate for facilitating a fair, transparent and competitive Bidding Process.

SECTION - 7
MISCELLANEOUS

- 7.1. The Bidding Process shall be governed by, and construed in accordance with, the laws of India and the Courts at Patna, Bihar shall have exclusive jurisdiction over all disputes arising under, pursuant to and/ or in connection with the Bidding Process.
- 7.2. The Authority, in its sole discretion and without incurring any obligation or liability, reserves the right, at any time, to;
- (a) suspend and/ or cancel the Bidding Process and/ or amend and/ or supplement the Bidding Process or modify the dates or other terms and conditions relating thereto;
 - (b) consult with any Bidder in order to receive clarification or further information;
 - (c) qualify or not to qualify any Bidder and/ or to consult with any Bidder in order to receive clarification or further information;
 - (d) retain any information and/ or evidence submitted to the Authority by, on behalf of, and/ or in relation to any Bidder; and/ or
 - (e) independently verify, disqualify, reject and/ or accept any and all submissions or other information and/ or evidence submitted by or on behalf of any Bidder.
- 7.3. It shall be deemed that by submitting the Bid, the Bidder agrees and releases the Authority, its employees, agents and advisers, irrevocably, unconditionally, fully and finally from any and all liability for claims, losses, damages, costs, expenses or liabilities in any way related to or arising from the exercise of any rights and/ or performance of any obligations hereunder and the Bidding Documents, pursuant hereto, and/ or in connection with the Bidding Process, to the fullest extent permitted by applicable law, and waives any and all rights and/ or claims it may have in this respect, whether actual or contingent, whether present or in future.

- (c) this Agreement is the legal and binding obligation of such Party, enforceable in accordance with its terms against it; and
- (d) there is no litigation pending or, to the best of such Party's knowledge, threatened to which it or any of its Affiliates is a party that presently affects or which would have a material adverse effect on the financial condition or prospects or business of such Party in the fulfillment of its obligations under this Agreement.

8. Termination

This Agreement shall be effective from the date hereof and shall continue in full force till the execution of the Contract by the SPV, in case the Project is awarded to the Consortium. However, in case the Consortium is either not qualified for the Project or does not get selected for award of the Project, the Agreement will stand terminated in case the Bidder is not qualified or upon return of the Bid Security by the Authority to the Bidder, as the case may be.

9. Miscellaneous

- 9.1 This Joint Bidding Agreement shall be governed by laws of India.
- 9.2 The Parties acknowledge and accept that this Agreement shall not be amended by the Parties without the prior written consent of the Authority.

OFFICE MEMORANDUM

Sub: Guidelines for qualification of Bidders seeking to acquire stakes in Public Sector Enterprises through the process of disinvestment

Government has examined the issue of framing comprehensive and transparent guidelines defining the criteria for bidders interested in PSE-disinvestment so that the parties selected through competitive bidding could inspire public confidence. Earlier, criteria like net worth, experience etc. used to be prescribed. Based on experience and in consultation with concerned departments, Government has decided to prescribe the following additional criteria for the qualification/ disqualification of the parties seeking to acquire stakes in public sector enterprises through disinvestment:

- (a) In regard to matters other than the security and integrity of the country, any conviction by a Court of Law or indictment/ adverse order by a regulatory authority that casts a doubt on the ability of the bidder to manage the public sector unit when it is disinvested, or which relates to a grave offence would constitute disqualification. Grave offence is defined to be of such a nature that it outrages the moral sense of the community. The decision in regard to the nature of the offence would be taken on case to case basis after considering the facts of the case and relevant legal principles, by the Government of India.
- (b) In regard to matters relating to the security and integrity of the country, any charge-sheet by an agency of the Government/ conviction by a Court of Law for an offence committed by the bidding party or by any sister concern of the bidding party would result in disqualification. The decision in regard to the relationship between the sister concerns would be taken, based on the relevant facts and after examining whether the two concerns are substantially controlled by the same person/ persons.
- (c) In both (a) and (b), disqualification shall continue for a period that Government deems appropriate.
- (d) Any entity, which is disqualified from participating in the disinvestment process, would not be allowed to remain associated with it or get associated merely because it has preferred an appeal against the order based on which it has been disqualified. The mere pendency of appeal will have no effect on the disqualification.
- (e) The disqualification criteria would come into effect immediately and would apply to all bidders for various disinvestment transactions, which have not been completed as yet.

- (f) Before disqualifying a concern, a Show Cause Notice why it should not be disqualified would be issued to it and it would be given an opportunity to explain its position.
- (g) Henceforth, these criteria will be prescribed in the advertisements seeking Expression of Interest (EOI) from the interested parties. The interested parties would be required to provide the information on the above criteria, along with their Expressions of Interest (EOI). The bidders shall be required to provide with their EOI an undertaking to the effect that no investigation by a regulatory authority is pending against them. In case any investigation is pending against the concern or its sister concern or against its CEO or any of its Directors/ Managers/ employees, full details of such investigation including the name of the investigating agency, the charge/ offence for which the investigation has been launched, name and designation of persons against whom the investigation has been launched and other relevant information should be disclosed, to the satisfaction of the Government. For other criteria also, a similar undertaking shall be obtained along with EOI.
