



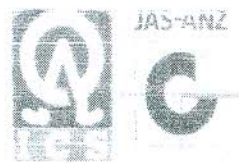

1. The quotationer of proposal should have prior experience of running office canteen / service of same nature of work of at least 3 Years.
2. Photocopy of PAN/TAN, VAT, Service Tax, Licensing of FSSAI & Registration in EPF/ESI Office must be submitted.
3. Menu & approved Rate of food items which is enclosed herewith would be valid for entire period of contract.
4. Menu items must be make available on discounted rate (Quoted by Successful quotationer) for Officer / Staff of Bihar Rajya Pul Nirman Nigam Ltd. **The criteria of selection of agency for running the canteen is one who quoted maximum discounted rate on approved rate.**
5. Items wise Discounted rate must be quoted in figures & words.
6. Canteen must be kept clean at all times and preparation / serving of food must be done in a hygienic manner.
7. Electricity Bill of Canteen will be paid by quotationer every month according to sub meter reading of canteen.
8. Rent of canteen will be @ Rs. 2500/- per Month or rent fixed by concerned government authority. Whichever is higher, would be paid to Bihar Rajya Pul Nirman Nigam Ltd.
9. Electric equipment like A.C., Fan & Furniture will be made available to quotationer by BRPNL. The maintenance of above electrical equipment & furniture would be done by quotationer. But the same

is required to be handed over in same condition to BRPNNL after termination / expiry of period of the contract.

10. If at any stage, service found unsatisfactory, quotation will be cancelled with one month prior notice.
11. The contract may be renewed for a period of one year if the performance in the proceeding period is found satisfactory.
12. Item wise rate quoted by quotationer, should not be exceeded than the approved rate.


