Prospective bidders shall have to bid OFFLINE i.e. the companies have to submit the actuarial premium rates in the prescribed format in a sealed envelope. It may be noted



that it is a financial bid only. Participation in the Financial Bid will imply acceptance of the terms mentioned in this bid document and the operational guidelines for PMFBY.
