For participating in the above E-Tendering process, the contractors shall have to get themselves registered with the service provider so that user ID, password and Digital Signature are issued to them. This will enable them to access the website www.eproc.bihar.gov.in and download / participate in E-Tender. 12. The undersigned reserves the right to extend or cancel or reject the tender/tenders at any time without assigning any reason thereof. No cost what so ever shall be claimed on such account by the bidder.
13. (i) Earnest money in any form as prescribed in rule 161 of the revised PWD code and duly endorsed/pledged to the authorized departmental representative ((**DGM (TECH), CPIU, BSRDCL Ltd**) can be in any of the following shapes or combination thereof:-
 - (a) Fixed Deposit receipt of Nationalized /Scheduled Bank.
 - (b) Post Office/Saving Bank Passbook.
 - (c) One, two or three years Post Office time deposit.
 - (d) NSC issued within the State of Bihar.
 - (e) 5 years National Development Bond.
 - (f) State Development Loan Certificate.
 - (g) FDR of Nationalized / Scheduled Bank
 - (g) For works costing more than one Crore, a Bank Guarantee of Nationalized/Scheduled Bank may also be submitted.

The above instrument(s) shall remain valid on / after the start date of uploading of document by the employer and before / upto the stipulated last date of uploading the bid by the bidder shall only be applicable. It should be valid for not less than 180 days.

 - (ii) Earnest money deposit (EMD) can be paid either through manual mode (BG, DD etc.). In case of manual mode of payment of EMD, the original hard copy of the EMD which may be a DD/NSC/KVP/BG/FDR or any other instrument that should be submitted in the tendering authority office within the next working day after tender closing date.
- 14.(a). A scanned image of form Fee instrument (Cost of B.O.Q which is Rs. 10000), paid in the form of D.D of any nationalized/scheduled bank in favour of DGM (Tech),BSRDC Ltd and payable at Patna to be uploaded along with the tender documents.
 - (b) A scanned copy of the instrument(s) for Earnest Money as described in Clause 17 above to be uploaded along with the tender documents.
 - (c) In respect of 15(a) and (b), the bidder shall also upload details of the instrument(s) including amount, date, serial no., bank on which drawn, office in favour of whom it is drawn/pledged and the place where they are payable.
 - (d) "Bid processing fee is mandatory to be paid through online mode i.e. internet payment gateway (Credit/Debit Card), Net banking, NEFT/RTGS"
 - (e) "Bids along with necessary online payments must be submitted through e-procurement portal www.eproc.bihar.gov.in before the date and time specified in the NIT. The department does not take any responsibility for the delay/Non Submission of tender/Non Reconciliation of online payment caused due to none availability of internet connection, network traffic/holidays or any other reason."
15. Bidders/ Contractors can access tender documents on the website and must fill them and submit the completed tender documents in electronic form on the website itself. Bidders/ Contractors shall attach scanned copies of all required papers, DD and certificates as required in the eligibility criteria. All the uploaded documents shall have the signature of bidder or their authorized signatories. The scanned copies should be of the original papers and certificates.
16. Corrigendum/ Addendum, if any, will be published on the website itself.
17. Before uploading tenders, bidders are advised to go through the SBD uploaded with the tender document.

18. Contractor will have to deposit additional performance guarantee for seriously unbalanced rate quoted by him at the time of agreement as per RCD letter No.3376(E)WE dated 17.08.10
19. In the unlikely event of the server for www.eproc.bihar.gov.in being down for more than two consecutive hours (in the period from midnight to closing time for receipt of tenders) on the last date of receiving of bid, the last date of the same shall automatically be extended to next working day till the last receiving time stipulated in the original NIT.
20. The bidders are requested to check their file size of uploaded documents at the time of submission & they should ensure that work file is uploaded. If they feel that the complete file is not uploaded then they should click on cancel & update the same before submission. The bidders should satisfy themselves of Download ability/visibility of the scanned & uploaded file by them.
21. The bidders are directed to zip their files using WinZip or WinRAR software only. Other formats of zipping will not be accepted and will be rejected.
22. The bidder must use MS Office-2007 or lower version.
23. File size should be less than 5MB and should be in Ms Word, Ms Excel, PDF and JPEG formats.
24. No claim shall be entertained on account of disruption of internet service being used by bidders. Bidders are advised to upload their bids well in advance to avoid last minute technical snags.
25. Estimated cost, cost of BOQ and earnest money may be increase or decrease.
26. The GST is effective on material from dated 01-07-2017. Rates of work items have been prepared on present GST rate. In future if any deviation in GST rate of materials take place, it will be effective and it will be a part of Tender Condition.
27. Conditional bid is liable to be rejected.
28. Defect liability period of work will be one years.
29. There is no provision of Incentive in this work.
30. All the latest guideline of RCD, Bihar will be effective in this Tender.
