## GENERAL INSTRUCTIONS /TERMS &amp; CONDITION TO BIDDERS

A TWO BID SYSTEM

(a) Tenderers must submit their bid in duplicate in two parts viz. Part I- Technical and commercial and Part-II Price. Both Part I & II must be sealed in separate envelope and both these sealed envelopes should be submitted together under one envelope duly sealed. (The envelopes containing Part-I and II should be exclusively wax sealed/PVC Tape sealed and the cover containing both these envelopes may be either wax sealed or sealed with PVC tape.) All the three envelopes should be super scribed on top with NIT Number, due date of opening and Part No. and should be addressed to the undersigned with Name & Address of bidder.

(b) The Tender (Both Part-I & Part-II) not sealed properly is liable for rejection. Mere pasting of envelope is not sufficient. Tender containing price in Technical bid (i.e. Part-I) is also liable for rejection. Any condition in any form containing in Price Bid (Part-II) shall be ignored or tender shall be liable for rejection.

(c) Tenders duly filled in should be dropped in the Tender Box in the office of the Electrical Superintending Engineer, E/M-cum-C&I Circle, BTPS on and before the due date and time. After that the Tender receipt box shall be sealed and opened at the due time of opening. BTPS shall not be responsible for any delay/loss of tender document sent by post/courier. No Tender shall be received by any office staff directly other than Post/Courier.

(d) Part-I of the tender will be opened on the due date and time as mentioned in the tender notice in presence of attending tenderers or their authorized representatives, if present at the due date and time of opening. Part-II (Price part) of the tenders/offers shall be opened of only those bidders, who are Techno-commercially accepted on a later date which shall be intimated to Techno-commercially accepted parties in advance either by telephone/FAX/put up on Notice Boards of Administrative Building of BTPS.

(e) Tender document is not-transferable.

(f) The Tenderer is requested to be in constant touch with the web site of the Bihar State Power Generation Company Limited for any information regarding date of extension (if any) of this NIT.

(g) The tenderers are advised to go through the tender documents carefully.

(h) The tenderers offer will be comprise submission of all relevant documents as per requirement of tender.

(i) All page of tender documents/submitted documents should be signed and stamped by tenderer carefully before submitting their tender.

(j) The tenderers will have to comply all the statutory rules and regulation as may be applicable.

(k) In case of tie between two or more bidders at L-1 position, all the L1 bidder shall be asked for discount our previous quoted rate/total amount in sealed envelope.

(l) Negotiations will not be conducted with all bidders as a matter of routine. However the department reserves the right to conduct rate negotiations.

B EARNEST MONEY

The tender/bid must be submitted along with Earnest Money @2% of the **estimated cost** as mentioned in tender notice i.e. Rs.13,700/- either in cash or in shape of Bank Draft payable in favour of the Accounts Officer, Barauni Thermal Power Station. Cheque is not acceptable towards deposit of EM. No bank charges or interest will be payable on the Earnest Money by the Company. Earnest Money must be deposited before the submission of the bid. Tender/bid submitted without EM will be rejected (except if under exemption as mentioned in 'C').

Tenderer is required to enclose the original money receipt if EM is deposited in cash or the relevant document on which the exemption is claimed if the tenderer comes under the category "exempted from EM".

In case the Tender is for supply of a number of materials and the bidder is not interested to supply all the items, in that case the Bidder shall have to deposit EM @2% of the quoted rates. In such case the bidder shall have to clarify in Part-I the name of materials in which he/she is interested.

C EXEMPTION FROM EARNEST MONEY

Tenderers of the following categories are exempted from depositing Earnest Money.

- 1) Govt. Of Bihar/Govt. of Bihar undertaking/ Govt. of India/ Govt. of India undertaking/SSI Unit of Bihar registered with the Department of Industries Govt. of Bihar or with DGS&D through National Small Industries Corporation for manufacture of the item in the quantity as specified in the tender.
- 2) Firm registered with the SSI unit/ National Small Industries Corporation under single registration subject to the monetary limit specified in the enlistment certificate provided that registration certificate is valid on the date of tender and schedule delivery period.

D REFUND/FORFIET OF EARNEST MONEY

Earnest money deposited will be refunded to the unsuccessful tender on written application No interest on earnest money will be payable by the Company.

In the event successful tender fails to sign the contract agreement with the Company within thirty days after receiving notice of award of contract/ LOI fails to submit contract guarantees as specified in tender document, the earnest money deposited will be forfeited. Earnest money of successful tender shall be refunded after furnishing of contract guarantee and signing of contract agreement or the money deposited as E/M can be converted as balance money for Security Deposit.

E VALIDITY PERIOD

The tender must specify the validity period of their offer which should be valid for a minimum period of 6 calendar months from the date of opening of the tender.

F DELIVERY

The materials has to be delivered at our BTPS Stores (Equipment stores, BTPS).The tender must give its acceptance to the information given in the delivery schedule in the tender document/Performa. The material has to be delivered on the basis of the delivery schedule which shall be provided by the consignee after the placement of order. The tenderer has to maintain the delivery schedule with respect to quantity assigned to them, which shall be based on the requirement of the power station and shall have to strictly comply with it. Any laxity in compliance to the delivery schedule shall be deemed as breach of the contract and the contract may be considered for cancellation.

G MANUFACTURING CAPACITY & PAST EXPERIENCE

In support of the manufacturing capacity and past performance the tenderer must furnish full information in the prescribed Performa

H PENALTY

The delivery schedule shall be guaranteed under penalty clause. Company shall apply penalty @1/2% (half percent) of the value of material (FOR destination) delayed for each fortnight or part thereof, with a maximum ceiling of 5% (five percent). Tenderers must give their acceptance to the penalty clause, otherwise tender will be considered invalid and rejected.

I SECURITY DEPOSIT or BG FOR CONTRACT GUARANTEE

Successful tenderer shall have to furnish Security Deposit as contract guarantee in shape of cash/ Bank Guarantee in favour of Accounts Officer, BTPS from any scheduled Indian Bank equal to 5% (five percent) of the contract value (landed price) within a week from the date of issue of LOI. In case of Bank Guarantee, it must be valid up to three months beyond the completion of commissioning and guarantee period. The validity of this BG will have to be extended in case the delivery schedule is subsequently extended with or without penalty, up to three months beyond the extended delivery period. In case of BG it has to be submitted in prescribed form of the Company. The expenditure involved in furnishing the BG is to be borne by the supplier.

J. PERFORMANCE BANK GUARANTEE

To ensure successful performance of the materials supplied under the contract, the Supplier shall have to furnish performance guarantee before supply of material of value equal to 5% (five percent) value of the contract price (landed price) in similar manner as specified above in respect of contract guarantee from any Indian Bank (PSU) in favour of Accounts Officer, BTPS valid up to 18 months from the date of consignment. The performance guarantee BG shall be valid up to three months beyond the completion of the delivery period.

L. CERTIFICATE FROM CENTRAL EXCISE DEPARTMENT

The supplier (Authorized dealer/Manufacturer) is required to furnish/ submit Invoice as per rules issued by the Central Excise Department indicating the name of the Central Excise Range/ Division and C.E. Registration No. Payment of ED will be withheld if such invoice does not exist.

K. INCOME TAX & SALES TAX

The tenderer is required to submit the attested copies of the following:

- 1) Central & State Sales Tax registration certificate
- 2) PAN
- 3) Last year's Income Tax Return.

M. QUANTITY

The quantity requirement given in the NIT and the tender document is tentative, which may increase or reduce at the time of finalization of the tender.

N. TERMS OF PAYMENT

Company's standard terms of payment is : 100% (Hundred) of the value of goods with full value of taxes and duties shall be paid after SRV, after submission of bill in triplicate to the consignment, subject to the availability of fund. Terms of Payment other than this only can be considered, if the Tenderers is a Public Limited Company/Public Sector unit.

\*Paying Authority: - Paying Authority shall be Accounts Officer, BTPS. He will process the duly verified bill in all respect for Payment. Subject to the availability of fund.

O(i) RIGHT TO SPLIT ORDER

The Company reserves the right to split the order amongst other Tenderers as well as, not to accept the lowest tender either in whole or part without assigning any reason.

O(ii) TERMINATION OF CONTRACT

The Company reserves the right to terminate whole or part of the contract of those suppliers who are found defaulter for delayed supply of material or materials supplied are found to be of sub-standard quality or are not in accordance with the prescribed specification. The supplier shall be liable for any loss, which Company may sustain on this account. The Company shall exercise its rights and remedy available to it under the general law of India relating to contracts and for fitted the EM/Security money/Performance money.

O(iii) NEGLIGENCE

If the supplier shall neglect to supply the materials with due negligence and expedition or shall refuse or neglect to comply with any reasonable orders given to them in contravention of any provision of the contract, the purchaser may give seven days notice to the supplier to make good the failure, neglect or contravention complained of, and if the supplier shall fail to comply with the notice within reasonable time, the purchaser shall be entitled to retain and apply any balance which may be otherwise due on the contract to the supplier or such part thereof as may be necessary, to the payment of the cost supply of such material as aforesaid.

O(iv) RIGHT TO REJECT THE TENDER/BID

The Company reserves the right to accept/ reject the tenders without assigning any reason thereof. The tenders which are not completely filled/ signed/ in which standard Payment/ Delivery/ acceptance of specification clause is not accepted and price is not mention in both numerals and words are liable to be rejected.

P. PRICE :- F.O.R. Destination (BTPS Store).

Normally only firm prices shall be required to be quoted by the Tenderers. Price should be quoted in Part-II (Price Part) only and it should not be mentioned in Part-I.

Q. TAXES – Clearly mention that it is inclusive or exclusive for deciding Landed cost at BTPS.R. INSURANCE

The supplier has to arrange for transit insurance of the materials supplied up to BTPS Stores in case where Prices quoted are F.O.R. ex-works basis then the materials shall have to be insured for transit to BTPS Stores in case of door delivery, for which either insurance charges shall be reimbursed as per actual or under Company's open marine policy for which the supplier is required to fill the requisite proforma of the Company and act as instructed. Any lapses by the supplier in this account shall be treated as negligence on their part and they will have to make good for the losses. Material found short from sound intact cases shall be deemed as short supply and the supplier shall have to make good the losses.

S. DO'S & DON'TS

After opening of the sealed bids Part-I, no tenderer shall correspond with the Company in respect of the NIT. Such correspondence even if received will not be included as a part of the tender bid and shall not form part of tender record. However clarifications asked by the purchaser shall be considered as a part of his bid.

**Agreement**: - The successful bidder will have to execute contract agreement on non Judicial Stamp for Rs.1,000.00 (Rupees One Thousand)only after issue of LOI and submission of Security Bank Guarantee.

T. ELIGIBILITY

Only the Original Equipment/material manufacturers and their authorized distributors/authorized dealer of related company are eligible to participate tenders against this NIT. In case of authorised distributor/dealers/specialist they have to submit valid certificate of authorisation issue from original manufacturer with the tender documents.

U. PURCHASE OF B.O.Q./ TENDER PAPER

The Tender paper/ B.O.Q. can be downloaded from the web site of the Bihar State Power Generation Company Ltd. and sent with requisite tender document cost (in shape of Bank Draft drawn in favour of the Accounts Officer, Barauni Thermal Power Station). Payable at BTPS, Begusarai Down loaded tender paper without correct tender document cost shall not be considered even after opening of Part-I.

V. GUARANTEE

All materials supplied shall be covered under Guarantee. The supplier shall have to undertake guarantee against all manufacturing defect/ bad workmanship/ inferior quality and specify the period. Any material rejected on above grounds will have to be replaced by the supplier free of cost. The decision of the department regarding quality of material will be binding upon the supplier. Company's standard Guarantee clause is for 12 months from the date of commissioning and 18 months from the date of supply whichever is earlier.

W. JURISDICTION OF COURT

The Civil Court of Begusarai shall alone have the exclusive jurisdiction to decide any dispute/ claim arising out against this tender.
