1. INDIA has applied for financing from the Asian Development Bank (ADB) towards the cost of Bihar New Ganga Bridge Project. Part of this financing will be used for payments under the contract named above. Bidding is open to prequalified Bidders from eligible source countries of the ADB.
2. The Bihar State Road Development Corporation Limited, (the "Authority") invites sealed bids from Prequalified eligible Bidders for the design, construction and completion of Greenfield Six- Lane Extra dosed Cable Bridge over river Ganga near Kachchi Dargah in District Patna on NH-30 to near Bidupur in District Vaishali on NH-103, (Bihar). Length of the project 22.76 Km includes 9.76 Km long main bridge ("The Works") on EPC mode. The project also includes performance based maintenance for a period of 5 years on completion of construction.
3. A firm will be selected in accordance with the procedure as described in this Bidding Documents. The Prequalified Bidders will submit Bids/Proposals in response to the requirements of the Bidding Documents, updating the information given at the time of prequalification to demonstrate that the bidder continues to meet the criteria used at the time of prequalification.
4. International competitive bidding will be conducted in accordance with ADB's Single - Stage: One - Envelope following Prequalification procedure and is open to all prequalified Bidders from eligible countries as described in the Bidding document.
