1. The Tenderer should submit quotations / Tenders in sealed Envelope superscribing the Tender Notice No.
2. We are giving here with Tender Schedule with specifications of the LED Back Lit Panel Light for BSRDCL HQ. Your quoted goods/material & accessories/allied components should be strictly as per our specifications, and should be given with detailed specifications.
3. Tenders / Quotations received late will not be considered and postal delay will not be entertained. The quotations in sealed covers should reach this office at Bihar State Road Development BSRDCL Ltd., RCD Central Mechanical Workshop Campus, Near Patna Airport, Sheikhpura, Patna 800014 on or before date **29.11.2016** at 3.00 PM.
4. Sealed cover should be super scribed as “NOTICE INVITING TENDER FOR SUPPLY & INSTALLATION OF LED FITTINGS AT BIHAR STATE ROAD DEVELOPMENT CORPORATION LTD.”
5. The Technical Bids will be opened on date **29.11.2016** at 3.30 P.M. and scrutinized all required documents / certificates and if qualified then opened qualified commercial bid if possible on same day or as per committee decision.
6. All the terms and conditions are enclosed herewith.

The Tenders / quotations should be under two Bid systems, One envelope containing Technical Bid having Tender Form / Tender schedule & specification and Number of Demand Draft of EMD and the other envelope containing financial bid along with Demand Draft of EMD for amount of 3 % of the total quoted cost in favour of Bihar State Road Development Corporation Ltd., payable at Patna. Both the envelope (sealed) should be put in One Big envelope and sealed and shall be submitted. E.M.D. amount will be refundable after 90 days without interest from the date of opening of the quotations.
8. The Tenderer should note that Envelope No. 1 must contain D. D. No. Date & Bank name of cost of document., registration of Shop under Shop Act and Sales Tax / VAT. Registration Certificate / Sales Tax clearance / exemption Certificate or SSI Unit Registration, Authorisation from Manufacturer or any documents required as per technical bid. The Envelope No.2 shall contain EMD i.e; 3% of the quoted rate alongwith financial bid.
9. The tenderer should quote the rates on quotation/our enclosed Tender schedule duly signed with date and seal of firm. He should not quote the rates anywhere directly or indirectly in Envelope No. 1.
10. If there is any correction in quotation, every correction/s in the rates should be initialled by the Tenderer.

TERMS AND CONDITIONS

1. The rates should be quoted inclusive of all taxes as F.O.R. Destination at our **BSRDCL HQ**.
2. The validity period for the rates offered should be clearly mentioned and it should be minimum 90 days from the date of opening of an items quoted should be confirms our specification, in addition, please furnish your detailed specifications against each item, the relevant catalogue/pamphlet should be necessary to accompany with the quotations.
3. The delivery period should be clearly stated.
 - a) Liquidated Damages: Firm should have to quote the delivery period clearly from the date of receipt of order or confirmed order.
 - b) If supplier fails to supply the ordered material within the scheduled delivery period, for late delivery of goods we will entitled to recover the liquidated damages as a sum equal to ½ percent of the price of stores delivered late per week.
4. The instructions manual for each equipment/components/machinery/material should be supplied separately with each item/s supplied.
5. Supplier's Technician/Engineer on free of cost must carry out the demonstration and installation at our site.
6. BSRDCL reserves the right to accept any/all quotations, reject any/all quotations and to order any of the item/s in any quantity without assigning any reason and to delete any item/s from Tender Enquiry
7. The items will be checked at the institute and acceptance is subject to the approval of the institute.
8. If the supply of goods/equipments/material or any part there of is rejected by BSRDCL, the supplier will have to bear all expenses incurred in the matter including all charges for return and replacement of the items. The rejected material/ equipments/parts of equipments should be got it back by supplier on their own cost.
9. **PAYMENT CONDITION:-**

85% Payment will be released after receipt of material in good condition and successful installation, testing & Commissioning. Rest 15% payment shall be paid after the completion of guarantee period.
10. The equipments should be guaranteed for minimum one year from the date of installation of the goods.
11. The repairs within the guarantee period must be carried out at own cost of supplier.
12. If any damages in transit, that should be repaired / or equipments should be replaced by the supplier of their own cost.
