The work shall be executed strictly in accordance with the specifications given in schedule of quantities and instruction of in-charge of works. The not covered or clarified by these specifications the same shall be carried out as per instruction of In charge of work.

1. NAME OF WORK:

Sealed item rate quotations/offers are for the various works described and detailed in schedule A-1, **A-2**, **A-3** and schedule-B of the offer document".

2. FILLING OF TENDER:

Offers not properly filled, mutilated with incorrect calculations or generally not complying with the condition may be rejected. Bidders should quote their rates both in figures and in words. The schedule or quantities must be fully priced and the total of each page along with carried over figures of the previous page shall be given in ink and signed by the tender. No blank spaces shall be left.

3. PROPRIETARY OF TENDER:

If the offer/quotation rate is made by or on behalf of a Company incorporated under the companies Act it shall be signed by the Managing Director or by one of the Directors duly authorized on that behalf. If it is made by a partnership firm it shall be signed with the Co-partnership name by a member of the firm who shall sign his own name and give the name and address of each partner of their firm and attach copy of Power of Attorney with the Tender/quotation/ rate authorizing him to sign on behalf of the other partners. A certified copy of the registered partnership deed shall also be submitted along with the offer. The work shall be executed as per specification entered in quotation/offer document and instruction of in-charge. Bidder is presumed to have studied the offer document & its specification, nothing extra will be paid for any item on account of its shape, size, location or other difficult circumstances even if the schedule makes no distinction, as long as entered in the quotation/offer.

4. SCHEDULE OF QUANTITIES

A schedule of approximate quantities for various items will be given to the successful bidder as purchase/supply order, which is liable to alterations by omissions, deductions or additions at the discretion of the client without affecting the terms of the contract.

## 5. BIDDER'S RATES

The bidders' rates must include the cost of transportation of material to the site, all taxes such as Sales Tax, Excise and Octroi etc. and the fixing or placing in position for which the items of work is intended to be operated. The rates shall be inclusive of all complete and no extra payment shall be made except specified in the item.

## 6. ACCEPTANCE OF QUOTATION

The acceptance of the offer/quotation will rest with the competent authority of the Directorate of Museum, Bihar, Patna who does not bind himself to accept the lowest quotation and reserves to himself the authority to reject any or all of the quotations received, without assigning any reason (s).

## 7. QUALITY

The competent authority of the Directorate of Museum, Bihar, Patna's decision regarding the quality of the material and workmanship will be final and binding. The in-charge of work shall, during the progress of the work, have power to check and order in writing form time to time for the removal of the faulty work, within such reasonable time or times as may be specified in the order, of any material which in the opinion of In-charge of works is not in accordance with specification or instructions. The substitution or proper re-execution of any work or replacement of bad material shall be borne by the bidder.

## 8. DISMISSAL OF WORK:

The bidder shall on the instruction of competent authority of the Directorate of Museum, Bihar, Patna immediately dismiss from work any person employed thereon by him, who way in the opinion of the client be unsuitable or incompetent or who may misconduct himself. Such discharges shall not be the basis of any claim for compensation of damages against the client or any of their officers or employee.

## 9. COMMENCEMENT OF WORK:

The Contractor shall commence the work on site within 10 days from the date of receipt of work order/Letter of Intent.

## 10. INCOME TAX AND OTHER TAXES

Statutory deduction of Income tax/ sales tax on works, contact shall be made from all interim and final payments as per present statute, including deduction.

## 11. DEFECTS LIABILITY PERIOD SIX MONTHS

Any defects developed within 'Defect Liability period' of 6 months from the date of COMPLETION will have to be rectified by the contractor. The rectification of such defects

shall be taken immediately on receipt of written notice from the client and such defects may extend 'liability period'. In case of failure to do so the client shall get the rectification work done by any other agency at the risk and cost of the bidder.

#### 12. SECURITY MONEY:

The security money @ 10% of each running bill shall be deducted. The 5% security money shall be refunded along with final bill. Balance 5% security money shall be retained up to six month against defect liability period that may be release after completion of successful defect liability period without any interest..

#### 13. SUPPLY OF MATERIALS TOOLS AND PLANT

The contractor shall arrange all the material required for the work.

#### 14. PAYMENTS

The payment shall be made against the bill submitted by the contractor and prepared by the engineer in-charge, based upon the joint measurement by the Contractor. Contractor shall submit 3 copies of the bill and 3 copies of the supply challan. Payment can be released within 15 days after submitting the bill to competent authority of Directorate of Museum, Patna

#### 15. LIQUIDATED DAMAGES

Entire work will be completed and handed over within stipulated period as mentioned in work order/letter of intent. Client/Owners shall levy liquidated damages at the rate of 1% of the total contract value, per week of delay, up to a maximum of 10 % of the total value of the work.

#### 16. EXTRA ITEMS

- (a) The rates of all authorized extra items or additional, altered or substituted supply shall be worked out as follows:
  - (i) The rates shall be based on or derived from the existing rates in the contract as far as and to the maximum extent possible from the same class & nature of work.
  - (ii) Where the rates cannot be derived in the manner of (i) above, the same shall be worked out on the basis of Market Rates or actual expenditure incurred in the execution of the items inclusive of taxes. Octroi etc. plus 10% for contractor's profit and overheads and supervision charges etc.
- (b) The rates of extra item as decided by the competent authority of Directorate of Museum, Bihar, Patna shall be binding to both the parties and shall not be subject to Arbitration.

## 17. WATER AND ELECTRICITY

The bidder shall arrange water, electricity, working area, storage room, lounging area etc, if some work is to be carried out at the site. The Museum authorities will not take any responsibility for the same.

## 18. SAFE STORAGE OR MATERIALS

The bidder/supplier shall be responsible for the safe storage of material use in the work.

Directorate of Museum, Patna is not responsible for any damage or loss to the bidder/supplier's material supplied, but not received by the museum authority due to some valid reasons .

## 19. TRANSPORT OF MATERIALS

Unless otherwise specified, all the materials supplied by the bidder shall be transported by them to the site of work at no extra cost.

## 20. COST OF SAMPLES

The Contractor at his own cost shall supply all samples.

## 21. QUALITY OF MATERIALS, WORKMANSHIP AND TESTS

All materials and workmanship shall be of the respective kinds described in the supply/purchase order and in accordance with In-charge of works or his Representative may direct at the place of manufacture of fabrication or on the site or at all or any of such places.
